Administrative Instruction No. 1022.

Sub: Modification in Clause No.3.1 of Administrative Instruction No.890 dated 17/01/2007.

All retired employees or their spouses in the case of deceased retired employees who are eligible to be covered under the IREL Post Retirement Medical Scheme 2007 as per Para 3.1 of Administrative Instruction No.890 dated 17/01/2007 are eligible for annual payment of Out-Patient-Treatment-Benefit (OPTB) of Rs.2500/- in case of workmen, and Rs.5000/- in case of officers in every Calander Year. This include those retired under VRS or their spouses also.

The above amount is revised w.e.f. 1st January 2013 as under:

Sr.No.	Category		Eligible Amount
1.	Workman	-	Rs.5,000/-
2.	Officers	-	Rs.10,000/-

The above payment is to be made from 1st January of the particular year upto 31st December of that year subject to all other terms and conditions of A.I. No.890 dated 17/01/2007 and A.I. No. 898 dated 15/03/2007.
