1) SCOPE OF SUPPLY OF BOILER COAL

1.1 The scope of supply of Boiler coal quantity of 11500 MT on FOR Destination basis by rake & by road through trucks. Overall tolerance -10% is allowed on the total coal quantity of 11500MT.

Delivery schedule:

1. lot of upto 4000 MT coal shall be supplied through rake within 40 days from the placement date of order.
2. lot of upto 4000 MT coal shall be supplied through rake from 41 days to 150 days from the placement date of order.
3. lot of upto 3500 MT coal shall be supplied in staggered basis through trucks by road within 150 days from the placement date of order. The staggered qty. maximum 2000 MT shall be delivered within Fifteen (15) days after the written communication from IREL.

Note: Rake lots of coal shall be supplied within 40 days & 150 days respectively from the placement date of order and trucks coal upto 2000 MT of quantity by trucks within fifteen (15) days after the written communication from IREL failing which LD will be levied as per the terms & conditions of each lot.

Seller is responsible for obtaining mining permits for supply of materials as per grade specified in the IOREL specifications including all charges like user fee, application fee, etc, if any, as per the rules of respective State Mining authorities.

1.2 Price should remain firm till complete execution without any escalation whatsoever.

2.0 Weighment and billing:

Determination of quantity shall be as per the weight of coal recorded at IREL's weighbridge. Payment shall be made on consignment-to-consignment basis taking into account of coal as determined at IREL's weighbridge / RR weight, whichever is less affecting recoveries towards GCV, total moisture and ash content, if any. The tare weight written on the RR will be considered as the tare weight. For determining the weight of received coal quantity difference between gross and tare weight will be considered. In case weighbridge is out of order at unloading end, RR Weight will be considered for loaded rakes. You may depute your representative to be present at all times when the weight is being computed/ calculated at your own cost.

3.0 Tests:

The sample of coal as received will be collected by IREL in presence of your representative and tests will be carried out by IREL's Laboratory. If your representative is not present at the time of sampling, the sample collected by IREL's Laboratory will be considered for testing. The results of the tests carried out by IREL's La

laboratory shall be treated for adjustments in payments, if any. Cost of collecting samples and testing in lab shall be borne by IREL. In the event of coal not meeting the minimum quality criteria mentioned in Technical Specification, the said lot will be rejected. If you do not agree to the test results, you can seek third party analysis at mutually agreed Govt. approved NABL Lab. IREL shall arrange for analysis of the referee sample at the mutually agreed Govt. approved NABL Lab & shall be tested in the presence of both the parties (Bidder & Buyer) whose results shall be final and binding. The cost of analysis incurred as above shall be borne by you. Sample collection, Sample preparation and testing shall be carried out as per latest IS Standards (IS: 1350).

4.0 Rejection: Coal received not meeting the acceptable parameters/specifications i.e GCV <2800Kcal/Kg, Ash Content (ADB) >50%(by Weight), Volatile matter > 28%(by Weight) & Fixed Carbon < 22% (by Weight) mentioned in order shall be rejected. No payment for rejected coal / the logistic charges for the concerned supply shall be made, irrespective of consumption status of the rejected coal. The coal lot rejected shall be taken back by you within 30 days from the date of intimation by IREL from its premises. In case you fail to lift the reject coal within the stipulated time, IREL shall take necessary action as deemed fit including shifting of the rejected coal at CONTRACTOR'S / TENDER'S RISK & COST. IREL will not be held responsible or liable for any consequential losses, whatsoever, to you arising out of such an eventuality. You will be entirely responsible and liable for such eventuality.

5.0 Deviation in coal specification and penalty calculations:

Sample will be taken from each rake and the parameters like GCV & Total Moisture will be evaluated on the basis of coal received at destination. Coal sampling and testing will be done on rake-to-rake basis and deduction of payment, if any, shall be made on rake-to-rake basis. Any adverse deviation from the desired value of the parameters mentioned above will be penalized and payment on this ground will be deducted as below:

i) For shortfall in GCV:

Guaranteed GCV (ADB) shall be 3000Kcal/Kg

If the actual GCV(ADB) is below guaranteed levels & upto 2800Kcal/Kg, then the basic price shall be adjusted as follows:

Adjusted price = Basic price X actual GCV(ADB)

GCV 3000 Kcal/kg

ii) Moisture

Maximum allowed moisture is 15% w/w. Payment shall be made on pro-rata basis after deducting moisture content above 15% (ARB). Excessive portion will be deducted from the dispatch lot weight as per follows:

Invoice weight(inMT) = Total dispatch lot weight(inMT) X {100- (Actual Total Moisture % - 15%)}

iii) For shortfall in Size

As per the Specifications, the percentage guaranteed limit for size range (1-150mm) is minimum 90%. However, if any out of sized material (i.e., Size <1 mm & Size >150mm) is observed, the penalty for shortfall in size shall be deducted from the bill as per formulae given below:
