1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Prequalification criteria (PQ) of the Tender.

1. The certification bodies who are participating in this bid shall have valid accreditation from NABCB. The agency should be accredited in the scope sector for ISO 9001:2015 (scope sector IAF 2 (07.21 & 08.91), ISO 14001: 2015 (scope sector IAF 12) and ISO 45001:2018 (scope sector IAF 12).
2. The bidder (certification body) who is participating in the bid shall have the accreditation in their name. The accreditation certificates should clearly indicate the bidder's name, accreditation number, date of issue, and expiry date.
3. The bidder (certification body) must provide valid and up-to-date accreditation certificates issued by accreditation board (NABCB).
4. Any bids submitted by an agency on behalf of certification agency shall not be acceptable and shall be summarily rejected.
5. The auditing agency (certification body) shall have experience of carrying out minimum five certification / re-certification audits against requirements of ISO 9001:2015, ISO14001:2015 and ISO 45001:2018 of any Central Govt. Organisation(s)/ Public Sector Undertaking(s) during last seven years ending December 2024. Documentary evidence shall be provided in this regard. Past Performance certificates from the companies are to be submitted.
6. Documentary evidence must be submitted along with the tender document for evaluation of pre-qualification criteria as mentioned above.

All other terms and conditions in the tender document shall be applicable.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
