The request for clarification shall be given asking the tenderer to respond by a specified date. If the tenderer does not comply or respond by the date, his tender will be liable to be rejected. Depending on the outcome, such tenders are to be i gnored or considered further. No change in prices or substance of the bid shall be sought, offered or permit ted.
