- 1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. - i) **Rejection Criteria -** If purity in EDTA is less than 96.00%, then whole material will be rejected. In case of rejection of Material, it will be replaced by the party at their own risk and cost, and supply the accepted qua lity material within 15 days from the date of rejection.
- ii) **Testing -** Material will be Tested at IREL Central Laboratory for Acceptance for Quality and IREL Central L aboratory decision shall be final.
- iii) **Delivery Schedule -** The entire quantity of 750 kgs is to be supplied by the party in a single Lot within 03 months From the date of placement of purchase order.

5) Pre-qualification Criteria:

<u>Past Performance:</u> The Bidder or its OEM should have supplied same or similar category products in at least one of the last seven financial years before the bid opening date to any Central/ State Government, Public Sector Undertaking(s) or Private Organization s.
