4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1.0 SCOPE:

Supply of 2 no. of 2 TPH (2 start, 5 stage Non conducting cleaner) Electrostatic Plate separator (EPS) as per detailed specification, terms & conditions furnished in the tender including transportation to OSCOM stores on FOR Destination basis.

Unloading will be done by IREL at OSCOM Stores.

Erection & commissioning of the equipment shall be done by IREL at its site. The supplier shall extend supervisory support for commissioning of the equipment at site, if required by IREL, at no extra cost to IREL.

2.0 TECHNICAL SPECIFICATION

3.0 TIME PERIOD OF COMPLETION:

The delivery schedule shall be **40 weeks** from the date of approval of GA drawing. The GA drawing shall be furnished to IREL (India) Ltd within 7 days from the date of receipt of the purchase order.

4.0 TERMS OF PAYMENT

(a) 90% payment along with 100% taxes and duties shall be made towards supply against tax invoice within 30 days of receipt and acceptance of the item at IREL, OSCOM stores.

(b) Balance 10 % shall be released after successful erection and commissioning of the equipment or within 04 months from the date of supply whichever is earlier.

Note:

I. EPBG/BG shall be released on satisfactory performance of the equipment during the entire warranty period (12 months from the date of commissioning OR 18 months from the date of supply whichever is earlier)

II. The bidder shall quote on terms of price FOR OSCOM unit, Matikhalo, Ganjam, Odisha. The rate quoted shall be in Indian Rupees only and commissioning support shall be provided at site, if required by IREL at no extra cost.

5.0 MODE OF PAYMENT:

The equipment, material etc. shall be so packed and protected so as not to suffer any deterioration, damage or breakage during transportation / shipment, handling and storage in a tropical climate, ideally in wooden cartons. All exposed ferrous metal surfaces shall be covered with a suitable rust preventive compound of reputed make. Large items shall be individually crated

8.0 INSURANCE:

The Goods supplied under the Contract shall be fully insured in Indian Rupees against loss or damage during transportation/shipment and handling. For delivery of goods at the purchaser's premises, the insurance shall be obtained by the Supplier for an amount equal to 110% of the value of the goods from "Warehouse to warehouse" (final destinations) on "All Risks" basis including War Risks and Strikes.

9.0 TRANSPORTATION:

Delivery of the equipment/materials to IREL, (India) Ltd, OSCOM shall be done **by the contractor at their risk and cost.**

10.0 UNLOADING, HANDLING:

- a) Unloading at site shall be done by IREL at its cost.
- b) Procedure for unloading and handling shall be communicated by the supplier to IREL well in advance.

11.0 INSPECTION

The items will be inspected by IREL on receipt at IREL site. You may at your option depute your representative for carrying out joint inspection at site or else IREL may conduct inspection on its own. If it is found that any item does not conform to the specification given, or is defective in any manner, the same will be rejected and supplier should arrange for immediate replacement thereof, free of cost to us inclusive of all taxes & duties. Such replacement supplies will also be subjected to our inspection as above before acceptance. However, such supplies if delayed beyond the period of contract will be considered as late supply and will attract Liquidated damages.

12.0 TESTING AND COMMISSIONING:

IREL will install the machine at its site within a period of 3 months from the date of delivery and shall test and Commission of the entire system at site. If so required by IREL, the manufacturer / supplier's trained engineer/ technician shall extend necessary technical supervisory supports during installation and commissioning.

The FAC will be issued by the PURCHASER only on demonstration of the technical specifications. The warranty shall commence only from the date of the issuance of the FAC.

14.0 DOCUMENTS TO BE SUBMITTED:

The following documents (in English) shall be provided along with the Unit in both hardcopy and softcopy forms:

- a) Unloading & Handling Procedures.
- b) Operation and maintenance manuals.
- c) Troubleshooting procedures
- d) Wiring and other schematic diagrams
- e) List of components, spares and accessories.
- f) If there are any bought-out systems and components, manuals of these are desirable to be provided in hard/softcopy.
- g) Safety and security instruction manual should be provided.
- h) Warranty certificates as applicable

15.0 Warranty:

The materials/equipments and all accessories supplied shall be warranted against any defective material, malfunctioning or poor workmanship for a minimum period of 12 months from the date of installation and commissioning as indicated in FAC or 18 months from the date of supply, whichever is earlier.
