### 3. **Generic**

### 4. **Generic**

Dept./ State Govt./ Semi- Govt./ Autonomous bodies or private organizations during last Seven (7) years and meeting the value requirement as below:

Execution of at least one order for “similar supply(s) for a value of **not less than Rs. 236.00 lakhs**”

OR

Execution of two orders for “similar supply(s) for a value each **not less than of Rs 147.00 lakhs**”

OR

Execution of three orders for “similar supply(s) for a value each **not less than of Rs 118.00 lakhs**”

Intending tenderers have to furnish documentary evidence in support of the qualification criteria from concerned authority/department/organization for similar supplies executed like Copy of Completion / Performance Certificate along with order(s) for complying technical competency.
