1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. I) Technical competency: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied Electric operated rope hoist of minimum order value Rs.6.7 Lakhs in a (single or two) orders in last five years ending bid opening date to any Central / State Govt. Organization / PSU / Public Listed Company / private organizations. Copies of relevant contracts (providing supply of along with completion proof of like tax invoice / CRAC / E-way bills etc to be submitted along with bid in support of quantity supplied.

NB: For MSE & Start-Up Bidders Past experience is relaxed. However, bidders have to establish their technical competency by submitting supporting documents towards successful execution of similar work **for any value**, failure to which the offer will not be considered for evaluation.

8. Warranty
