NB: Interested bidder may visit the site & discuss with user department to understand the scope of work before part icipating in the tender. If any bidder has participated in the bid without site visit, it will be presumed that they have understood the total activities without any doubt.

Documents against the Pre-qualification criteria as above complete in all respect must be uploaded. Failure to comp liance of above shall make the bid incomplete and as such it shall be rejected. In the absence of receipt of Pre-qualif ication criteria, the offer will not be considered under any circumstances.

The offers of the bidders who have defaulted in the past in execution of the contracts or in complying with the obligations as per the contract of IREL(India)Limited shall not be considered.
