If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
5. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 6. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for

Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. ### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up

to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

## 2. **Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

## 3. **Buyer Added Bid Specific ATC**

### **PRE-QUALIFICATION CRITERIA**

#### **A. TECHNICAL:**

Original Equipment Manufacturer (OEM) or their Authorised dealers/ agents are eligible to participate in the tender. Authorised dealers/ agents are required to submit authorization letter from OEM. Tenderer should have supplied at least one number of Rare Earth Magnetic Separator in the last seven years ending November 2023 to any Beach Sand Mineral Processing Company.

The tenderer shall submit the copies of purchase orders, satisfactory work completion certificate / installation and commissioning report towards documentary evidence of the above as given below.

- a) Three similar completed works costing not less than the amount Rs. 16.0 Lakhs each OR
- b) Two similar completed works costing not less than the amount Rs.20.0 Lakhs each OR
- c) One similar completed works costing not less than the amount Rs.32.0 Lakhs each.

**Similar work means:** Supply of Rare Earth Magnetic Separator (Rare Earth Drum Magnetic separator (REDMS) / Rare Earth Roll Magnetic Separator (RERMS) to any Beach Sand Mineral Processing Company.

#### **B. FINANCIAL:**

Average Financial turnover of the participating bidder during last three consecutive years ending 31st March 2022 / 2023 shall not be less than **INR 12 lakhs**. Bidder shall submit audited Profit & Loss account/ IT Returns/ for the above periods is to be submitted.

### **SCOPE OF WORK/SUPPLY:**

Design, manufacture and supply of One Number of Rare Earth Drum Magnetic Separator (REDMS) for use at Monazite circuit as per technical specifications and terms and conditions of the tender.

### **Pre-delivery inspection and testing:**

Supplier shall arrange for pre-delivery inspection (PDI) of the equipment at their works before dispatch. On receipt of intimation from the supplier about their readiness, IREL(India) Limited shall carryout PDI at Supplier's place and conduct test work using feed samples to ensure the metallurgical performance and issue clearance for dispatch. However the final inspection on receipt of the equipment at IREL(India) Limited, Charara shall be the basis of acceptance of the equipment

### **INSTALLATION AND COMMISSIONING**

IREL(India)Ltd shall carry out the installation and commissioning of the machine at designated site. However, supervisory support shall be provided by the Supplier during erection and commissioning free of cost.

#### **TERMS OF PAYMENT**

1. 80% payment along with 100% taxes and duties shall be made within 30 days of receipt of equipment at IREL, Chavara site and acceptance by the Engineer-in-Charge after inspection.

2. 10% payment shall be made after erection and successful commissioning of the equipment.

3. Balance 10% payment shall be made 12 months after successful commissioning of the machine or 18 months from date of supply whichever is earlier.

Alternatively, on successful completion of commissioning, party can submit performance BG for 10% of contract value valid for 12 months with an additional claim period of 3 months. On submission of PBG as above, balance 10.0 % will be released.

4. Security deposit will be released after successful installation and commissioning of the equipment supplied

#### **DELIVERY PERIOD**

Delivery Period is 126 days from the date of receipt of order by the supplier.

#### **PACKAGING SITE HANDLING, STORAGE OF MATERIALS & EQUIPMENTS:**

The equipment, material etc. shall be so packed and protected so as not to suffer any deterioration, damage or breakage during shipment, handling and storage in a tropical climate, ideally in wooden cartons. All exposed ferrous metal surfaces shall be covered with a suitable rust preventive compound of reputed make. Large items shall be individually crated.

**GUARANTEE /WARRANTY:** The tenderer shall guarantee the equipment for design, materials, workmanship and satisfactory trouble free performance for a period of 12 months from the date of commissioning or 18 months from the date of receipt whichever is earlier

#### **MARKING ON PACKAGES:**

Each package will be marked on three sides with proper paint/indelible ink, the following (1) Purchaser Name & Address (2) Item Nomenclature (3) Order/Contract No. (4) Country of Origin of Goods (5) Packing list reference number

#### **INSURANCE:**

The Goods supplied under the Contract shall be fully insured in Indian Rupees against loss or damage during transportation/shipment and handling. For delivery of goods at the purchaser's premises, the insurance shall be obtained by the Supplier for an amount equal to 110% of the value of the goods from "Warehouse to warehouse" (final destination) on "All Risks" basis including War Risks and Strikes.

**TRANSPORATION:**

Delivery of the equipment/materials to IREL, (India) Ltd, Chavara shall be done by the contractor at their risk and cost.

**UNLOADING & HANDLING:**

Unloading at site shall be done by IREL at its cost. Any incidental expenses at IREL (India) Limited other than unloading charges have to be borne by the supplier.

**OTHER TERMS AND CONDITIONS:**

1.The contractor shall include all other equipment /components/ instruments etc. which are not described herein specifically but are deemed necessary for completeness, safety and satisfactory performance of the supply under their scope.

2.All terms and conditioned mentioned in the tender document including Specifications uploaded in the “**Specification document**” shall also applicable to this Bid.

**Disclaimer/अस्वीकरण**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of

this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
