The request for clarification shall be given asking the tenderer to respond by a specified date. If the tenderer does not comply or respond by the date, his ten der will be liable to be rejected. Depending on the outcome, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or permitted. No post bid clarification at the ini tiative of the bidder shall be entertained. The shortfall information / documents should be sought only in ca se of historical documents which pre-existed at the time of the tender opening and which have not un dergone change since then.
