1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Buyer Added Bid Specific ATC

Pre- Qualification Criteria (PQ)

1. Technical Qualification Criteria:

a) The bidder should have experience in bagging operations / machine or HEMM operation / any mainten ance works in Mining industry in the last seven years ending on 30.11.2024. In proof of the same, copies of work order and completion certificate

/ invoice copy/copies shall be submitted for verification. Accordingly, the bidder should have executed :

a) Three similar works costing not less than 40% of the estimated value.

- b) Two similar works costing not less than 50% of the estimated value
- c) One similar work costing not less than 80% of the estimated value

<u>Similar work</u> : Work related to bagging operations / machine or HEMM operation / any maintenance work s in Mining industry.

b) The bidder shall submit documentary evidence against the supervisor to be engaged for having super visory experience in bagging works in mining industry.

2. **Financial Qualification Criteria**: The average annual turnover the bidder for the last three consecuti ve years ending on 31.03.2023 shall not be less than 30 % of the estimate (without taxes). Audited copies of P&L account / Income Tax return for the last three consecutive years ending on 31.03.2023 shall be sub mitted for verification of the same.

3. **Site Inspection Criteria**: Interested bidders shall visit the site for getting clear understanding about t he operation of the semi-automatic bagging machines, various operations/activities like bagging, stitching, handling, transportation, re-bagging stacking etc. In addition, interested bidder should have clear understa nding about the go-downs, different areas of bagging, storage, labour rates & other conditions prevailing at Chavara, Kollam etc., to arrive at the rates.

Accordingly interested bidder/s shall conduct a site visit and upload the certificate issued by the Engineer-i n-Charge in proof of the same.

4. The bidder shall submit proof of Office Address within 20 Kms of IREL, Chavara, Kollam, Kerala (copy o f rent agreement/ land tax receipt/ electricity bill etc.) OR self declaration stating that the bidder will set up a Site Office within 20 Kms of IREL, Chavara, Kollam, Kerala, within 14 days in case of receipt of order.

5. Concurrent commitments

In order to assess the Bidder Capability and Spare Capacity to perform the assignment of execution of the tendered work, the bidder shall disclose all works being executed by them as per the format given below.

DETAILS OF CONCURRENT COMMITMENTS

The bidder will be disqualified if the annualized concurrent commitments of the bidder plus annualized esti mated value of the work under consideration exceeds 4 times the average annual turnover of the precedin g 3 years ending 31.03.2023. The bidder shall submit the 'Details of Concurrent Commitments' as per the

above table and Audited copies of the P&L account for the preceding 3 years along with the bid for verificat ion.

This bids meeting all the above PQ criteria only will be considered for further processi ng.

Period of contract : The period of contract will be for one year from date of commencement of wor k or Completion of the quantity/order value, whichever is earlier. The work shall be commenced within 15 days from the date of issue of Work Order or as intimated by the Officer-In-Charge.

IREL may also terminate the contract by issuing two weeks' notice without assigning any reasons. Further, the contract may also be terminated by IREL during the subsistence of the contract if any of the t erms and conditions of the contract is not complied with by the Contractor.

Payment terms: Payment shall be made on monthly pro-rata basis for the actual qu antity of works executed, within 30 days of submission of bills, verified and ve tted by the EIC.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
