- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any

Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

- 4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.
- 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

## **PRE-QUALIFICATION CRITERIA**

# The tenderer should submit the following towards Pre- Qualification Cr iteria.

1. Bidder shall have experience of supply of similar item during the last 10 years from the date of tender.

Similar item means: Supply of electrically operated pinch valve, modulating type

Documents in support of PQ Criteria should be uploaded.

Pre-Qualification Criteria can be relaxed for MSEs and Start up companies subject to meeting quality and technical specification.

Offers from vendors defaulted to IREL (India) Limited, Manavalakurichi during last one year will not be considered

#### **OTHER TERMS & CONDITIONS**

- 1. The Party has to upload the following along with the Bid
  - (i) Documents towards pre qualification of tender failing which offer shall not be accepted.
  - (ii) Copy of GST, PAN, MSME Registration
  - (iii) EMD Declaration
  - (iv) Undertaking provided in tender, duly filled and signed

- 2. The rate quoted shall be FOR IREL (India) Limited, Manavalakurichi. The item offered has to be supplied strictly as per the technical specification.

#### 3. **Delivery Period**

Supply shall be completed within 60 days from the date of issue of purchase or

der. Installation and commissioning shall be completed within 15 days from the date of site clearance by IREL.

# 4. Security Deposit (SD) (For supply orders above ₹ 5 Lakhs)

The successful tenderer has to submit Security Deposit @3% of the contract value in the form of RTGS/NEFT/ BG within 21 days of receipt of our PO as security for satisfactory completion of the order. The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on abandonment of the supply order. The EMD can be adjusted towards Security Deposit. However, if EMD is submitted in the form of BG, fresh BG is to be submitted towards SD in the prescribed format as per tender. If the Supplier fails to provide the security deposit within the period specified, such failure shall constitute a breach of the Contract and IREL shall be entitled to make other arrangements for the repurchase of the stores contracted for at the risk and expense of the supplier and/or to recover from the supplier the damages arising from such cancellation.

# 5. Earnest Money Deposit (EMD)

- 5.1. Rs.5,000/- (Rupees five thousand only)
- 5.2.Tenderer shall remit EMD through RTS/NEFT infavour of M/s. IREL (India) Limited,

- 5.3. Tenderer shall inform details of remittance of EMD through E-Mail/ FAX . - 5.4. Offers without EMD or valid EMD exemption certificate shall not be considered.
- 5.6. The EMD is liable to be forfeited if:
- i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the date of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 5.7. PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. MSME /SSI units—are exempted from payment of **EMD** provided they submit valid MSME/ NSIC certificate along with commercial bid and to ensure that certificate pertains to the class of item/ works for which floated.

#### 6. Payment terms

a. 70% payment of the supply part shall be paid on receipt of goods at IREL (India) Limited, Manavalakurichi in good condition & succes sful inspection, testing including functionality of valves and upon th e submission of the hydro test certificate & Material Test Certificate of valves along with the supply.

- b. 20% of Supply part and 90% of Commissioning part shall be paid a fter the successful installation and commissioning of the pinch valve s in hydrosizer.
- c. 10% payment for supply part and installation & commissioning ch arges shall be made only after installation & successful performance e test at IREL, Manavalakurichi and on submission of Performance B ank Guarantee of equivalent value valid till end of the guarantee period. The Performance BG will be released after completion of the guarantee period of 12 months from date of successful commissioning / 18 months from the date of supply, whichever is earlier.

# 7. Liquidated Damages

For delays attributable to the Supplier liquidated damages shall be levie d at the rate of 0.5% per week or part thereof on the value of unfinished s upply for each week of delay subject to a maximum of 5% of the total con tract value. However if separate period of completion is specified for certa in item of work or group of items of work at the time of issuing the order t he liquidated damage can be levied accordingly for the value of the item of work or group of items of work. The Purchaser may at his option and wi thout prejudice to any other method of recovery, deduct the amount of su ch damages from any moneys in his hands due to the Contractor. The pay ment or deduction of such damages shall not relieve the Contractor from his obligations to complete the work or from any other of his obligations a nd liabilities under the contract.

Wherever the supply / work is on turnkey or having a bearing in commissioning and performance of the system in total, LD shall be imposed on total value, in such cases.

## 8. Guarantee/Warranty

The party shall give guarantee/warranty for the control valve for a period of 12 months from the date of installation. During the guarantee/warranty period any cost towards repair/ rectification works including spares shall be borne by the party.

However, the cost towards site visit by the party's service personnel (1 person) to IREL for travelling, boarding & lodging will be borne by IREL at the rate offered per visit as per Sl.No. 3 in the price schedule

### 9. **Performance Guarantee:**

Ten percent of the ordered value will be kept as Performance Guarantee for a period of one year trouble free operation of the equipment and will be released after completion of the Guarantee Period or against submissi on of performance Bank Guarantee of equivalent value valid for 12 mont

hs from the date of commissioning.

10. In case of any discrepancy between Gem terms and conditions and Buyer added ATC, then buyer added ATC shall govern.
