1. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

## PRE QUALIFICATION CRITERIA

## 5. SECURITY DEPOSIT (SD),

## 7. Liquidated Damages

Subject to Article -32, if the SELLER fails to deliver any or all of the GOODS or performance the services within the time period (s) specified in the CONTRACT, the PURCHASER shall, without prejudice to his ot her remedies under the CONTRACT, deduct from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores delivered late, for each we ek or part thereof of delay. The total damages shall not exceed 10 (Ten) per cent of the value of delaye d goods. The LD cannot exceed the amount stipulated in the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value shall be reduced proport ionately for the delay and payment shall be released accordingly.

In the event the invoice value is not reduced proportionately for the delay, the PURCHASER may deduct the amount so payable by SELLER, from any amount falling due to the SELLER or by recovery against t he Performance Guarantee. Both seller and PURCHASER agree that the above percentages of price red uction are genuine preestimates of the loss/damage which the PURCHASER would have suffered on acc ount of delay/breach on the part of the SELLER and the said amount will be payable on demand withou t there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the PU RCHASER in the matter of applicability of price reduction shall be final and binding.

## 8. Warrantee/Guarantee:

The party has to provide guarantee/warranty for a period of 12 months from da te of commissioning.

If, within the warranty period, any equipment or components fail as a result of manufacturing defect, improper installation, or engineering fault, party shall re place or repair the components including all out-sourced / bought-out equipme nt not manufactured by the party, such as Instruments, Valves, Electricals etc., at no cost to IREL.

9. In case of any discrepancy between GeM GTC and Buyer ATC, terms stipulated under buyer ATC shall govern.
