- 2. # Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें

#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

#### 3. Buyer Added Bid Specific ATC

#### Pregualification criteria of the Tender:

#### **PQ1. Prior Experience Criteria:**

The bidder shall be an experienced service provider of desilting / dredging of harbour, ports or any legally designated water body using diesel operated dredgers having a minimum capacity of 100 tph (tons per/ho ur) or water discharge capacity of 1000 m<sup>3</sup>/hour or more for the desilting of sand.

#### **Tender stipulation on prior experience:**

To meet the above experience criteria,

The bidder should have successfully completed similar service contracts during the last seven years ending 31.03.2024 meeting any of the following:

- a) Three similar completed service contracts costing not less than Rs.1,92,57,600/- (40 % of the estimated value including GST) or
- b) Two similar completed service contracts costing not less than Rs.2,40,72,000/-(50 % of estimated value including GST) or
- c) One similar completed service contracts costing not less than Rs.3,85,15,200/-(80 % of the estimated value including GST)

Documents to be submitted;

<u>For Governmental service contracts</u>: Copy of work orders and its work completion certificate.

For non-governmental service contracts: Copy of work orders and its work completion certificates along w ith TDS- Form 16/ FORM No.26 AS / GST return to the extent of value of work experience.

#### **PQ-2. Prior Turnover Criteria:**

The average annual turnover of the bidder for the last three consecutive financial years ending on 31st Ma rch 2024 shall be at least Rs.1,22,40,000/- (30% of estimated value excluding GST).

**Documents to be submitted**: Bidder shall submit financial standing through latest Income Tax return (I TR)/ Annual report containing balance sheet and statement of profit & loss account for the relevant periods

In case the date of constitution/ incorporation of the bidder is less than three years old, the average turnov er in respect of the completed financial years after the date of constitution shall be taken into account for t his criterion. If financial details are not submitted for any of the years, the turnover will be calculated by di viding the total turnover as per the submitted documents by three.

## PQ-3: Quality & Technical Specifications:

**Technical Capability:** The bidder shall be a registered service provider of desilting / dredging of harb ours, ports or any legally designated water body using diesel operated dredgers having a minimum ca pacity of 100 tph (tons per/hour) or water discharge capacity of 1000 m<sup>3</sup>/hour or more for the desilting of sand. The bidder shall have sufficient technical capability for the successful execution of the work. To establish the bidder's technical capability the following details shall be submitted:

- a. **Manpower**: The bidder shall have sufficient manpower having experience and expertise for the s upervision and execution of the work. <u>The bidder shall submit documentary evidence showing det ails of site supervisors and operating staff along with their qualification & experience.</u>
- b. **Office & Maintenance Infrastructure**: The bidder shall have a functional Site Office and maint enance workshop arrangements within 50 km from the work site for the smooth execution of the work and to attend urgent breakdown requirements. The bidders having office facility as indicated above shall submit copy of any utility bill having the said office address that is not older than two month/Udyam Registration certificate /GST registration certificate as evidence in this regard. The bidders can also submit Rent/lease agreement, if the office is situated in leased/rented land.

Bidder shall <u>submit an undertaking stating that they will open an office and maintenance worksho</u> <u>p within 5 days in case of receipt of work order</u> within the radius of 50km from the work site.

The bidder shall submit documentary evidence in support of the same.

c. **Equipment & Machinery:** The bidder shall be able to engage minimum number of equipment' s required for the work as below: -

All the above machinery shall be of excellent operating condition and shall be manufactured after the year 2010. To establish the capacity of the dredger and date of manufacture, bidder should submit specification data sheet issued by OEM (original equipment manufacturer) of the dredger and document to prove the ye ar of manufacture (preferably invoices, registration certificate etc.)

In case of owned equipment's the bidder has to submit a <u>declaration with details regarding ownership.</u>

<u>In case of hired equipment's the bidder shall submit an undertaking</u> that the hired equipment required for this work will be hired and deployed, if this work is awarded to them. The bidder should submit valid lease agreement within 7 days of award of contract.

<u>PQ- 4</u>: Concurrent commitment: In order to assess the Bidder Capability and Spare Capacity to perfor m the assignment of execution of the tendered work, the bidder shall disclose all works being executed by them as per the format given below.

The bidder will be disqualified if the annualized concurrent commitments of the bidder plus annualized esti mated value of the work under consideration exceeds 4 times the average annual turnover of the precedin g 3 years. The bidder shall submit financial standing through latest Income Tax return (ITR)/ Annual report containing balance sheet and statement of profit & loss account for the relevant periods.

The bids qualifying PQ-1, PQ-2, PQ-3, & PQ-4 only will be considered for further processing.

<u>Period of contract</u>: Period of contract is for twenty four (24) months from starting of work as per the order by the contractor to dredge out 2,00,000 T of sand.

Payment to the contractor: Payment shall be made on monthly basis within 30 days o f the submission of the duly filled bill and after the actual work done is verified & certified by Engineer in Charge. Duly filled bill shall be submitted along with the details of breakdowns in a register duly signed by the contractor & Engineer-In C harge maintained for the purpose.

All other conditions of the tender shall be applicable

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <a href="attached categories">attached categories</a>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
