1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Buyer Added Bid Specific ATC

Prequalification criteria (PQ) of the Tender:

PQ1: Prior Experience Criteria:

The bidder should be an experienced service provider for Excavation, collection, loading, transportation and delivering of mineral sand OR any sand from mining areas to designated sites OR Mechanical loading, transportation & leveling of tails sand OR any sand.

Tender stipulation on prior experience:

To meet the above experience criteria,

The bidder should have successfully completed similar service contracts during the last seven years ending 31.05.2024 meeting any of the following:

a) Three similar completed service contracts costing not less than Rs.1,92,93,000/- (40 % of the estimated value including GST) or

b) Two similar completed service contracts costing not less than Rs.2,41,16,250/-(50 % of estimated value including GST) or

c) One similar completed service contracts costing not less than Rs.3,85,86,000/-(80 % of the estimated value including GST)

Documents to be submitted;

For Governmental service contracts: Copy of work orders and its work completion certificate.

For non-governmental service contracts: Copy of work orders and its work completion certificates along with TDS- Form 16/ FORM No.26 AS / GST return to the extent of value of work experience.

Definition of similar service/work contracts - "Excavation, collection, loading, transportation and delivering of any mineral sand OR any sand from mining areas to designated sites OR Mechanical loading, transportation & leveling of tails sand OR any sand."

PQ-2: Prior Turnover Criteria:

The average annual turnover of the bidder for the last three consecutive financial years ending on 31st March 2024 shall be at least Rs.1,22,62,500/- (30% of estimated value excluding GST)

Documents to be submitted: Bidder shall submit financial standing through latest Income Tax return (ITR)/ Annual report containing balance sheet and statement of profit & loss account for the relevant periods.

In case the date of constitution/ incorporation of the bidder is less than three years old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criterion. If financial details are not submitted for any of the years, the turnover will be calculated by dividing the total turnover as per the submitted documents by three.

PQ-3: Quality & Technical Specifications:

Technical Capability: The bidder shall be a service provider for Excavation, collection, loading, transportation and delivering of mineral sand OR any sand from mining areas to designated sites OR Mechanical loading, transportation & leveling of tails sand OR any sand.

- a. **Manpower:** The bidder shall have sufficient manpower having experience and expertise for the supervision and execution of the work. The bidder shall submit documentary evidence showing details of site supervisors and operating staff along with their qualification & experience.
- b. **Office & Maintenance Infrastructure:** The bidder shall have a functional Site Office within 50 km from the work site for the smooth execution of the work and to attend urgent breakdown requirements. The Bidders having Office facility as indicated above shall submit copy of any utility bill having the said Office address that is not older than two months/ Udyam Registration Certificate/GST Registration Certificate as evidence in this regard. The Bidders can also submit Rent/Lease agreement, if the Office is situated in leased/rented land.

OR

Bidder shall submit an undertaking stating that they will open an office and maintenance workshop within 5 days in case of receipt of work order within the radius of 50km from the work site.

- c. **Equipment & Machinery:** The bidder shall submit the details of the equipments to be deployed for the work as below: -

All the above machinery shall be of excellent operating condition and shall not be more than 10 years old from year of manufacture.

In case of owned equipment's the bidder has to submit a declaration with details regarding ownership.

In case of hired equipment's the bidder shall submit an undertaking that the equipment required for this work will be hired and deployed, if this work is awarded to them. The bidder should submit valid lease agreement within 7 days of the award of the contract.

PQ-4: Assessment of Site Conditions

Interested bidders shall submit self-declaration stating that they have assessed the site conditions before quoting and the same shall be uploaded along with tender documents.

PQ- 5: Concurrent commitment: In order to assess the Bidder Capability and Spare Capacity to perform the assignment of execution of the tendered work, the bidder shall disclose all works being executed by them as per the format given below.

The bidder will be disqualified if the annualized concurrent commitments of the bidder plus annualized esti

mated value of the work under consideration exceeds 4 times the average annual turnover of the preceding 3 years. The bidder shall submit financial standing through latest Income Tax return (ITR)/ Annual report containing balance sheet and statement of profit & loss account for the relevant periods.

The bids qualifying PQ-1, PQ-2, PQ-3, PQ-4 & PQ-5 only will be considered for further processing.

Period of Contract:

1. The work including transportation of mineral sand to the IREL, Chavara plant should be started within 7 days of the receipt of the work order. If there is a delay in start the work beyond 7 days, penalty will be levied @ of Rs.1000/- per day.
2. Period of contract is nine (9) months for mineral sand / tails sand transportation from the date of commencement of work of mineral sand/tails sand transportation.

Payment to the contractor : Payment shall be made on monthly basis within 30 days of the submission of the bill and after the actual work done is verified & certified by Engineer in Charge. All running bills shall be submitted along with the hindrance register duly signed by the contractor & Engineer-In Charge maintained for the purpose.

All other terms and conditions of the tender shall be applicable to this contract.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
