OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

The bidder shall be an experienced service provider of Erection work of any plant: Plant includes a sets of machinaries,tanks,steel structures which are used to execute any operation, "Set of items that is complete for its intended purpose" OR Mineral sand excavation, loading ,transportation, unloading using HEMMs OR Desilting operation using dredgers.

Tender stipulation on prior experience:

To meet the above experience criteria,

The bidder should have successfully completed similar service contracts during the last seven years ending 31.07.2024 meeting any of the following:

a) Three similar completed service contracts costing not less than Rs.1,75,26,261/- (40 % of the estimated value including GST) or

b) Two similar completed service contracts costing not less than Rs.2,19,07,826/-(50 % of estimated value

including GST) or

c) One similar completed service contracts costing not less than Rs.3,50,52,522/-(80 % of the estimated value including GST)

If audited financials/IT returns of FY 2022-23 are not available, then revenue from operations of FY 2020-21, FY 2021-22 & FY 2022-23 shall be considered.

PQ-3 : Quality & Technical Specifications:

Technical Capability: The bidder shall be a service provider of Erection work of any plant: Plant includes a sets of machineries, tanks, steel structures which are used to execute any operation, "Set of items that is complete for its intended purpose" OR Mineral sand excavation, loading ,transportation, unloading using HEMMs OR Desilting operation using dredgers. The bidder shall have sufficient technical capability for the successful execution of the work. To establish the bidder's technical capability the following details shall be submitted:

- a. **Manpower:** The bidder shall have sufficient manpower having experience and expertise for the supervision and execution of the work. The bidder shall submit docume

ntary evidence showing details of site supervisors and operating staff along with their qualification & experience.

- b. **Office & Maintenance Infrastructure:** The bidder shall have a functional Site Office within 50 km from the work site for the smooth execution of the work and to attend urgent breakdown requirements. The Bidders having Office facility as indicated above shall submit copy of any utility bill having the said Office address that is not older than two months/ Udyam Registration Certificate/GST Registration Certificate as evidence in this regard. The Bidders can also submit Rent/Lease agreement, if the Office is situated in leased/rented land.

OR

Bidder shall submit an undertaking stating that they will open an office and maintenance workshop within 5 days in case of receipt of work order within the radius of 50km from the work site.

All the above machinery shall be of excellent operating condition and shall not be more than 10 years old from year of manufacture.

In case of owned equipment's the bidder has to submit a declaration with details regarding ownership.

In case of hired equipment's the bidder shall submit an undertaking that the equipment required for this work will be hired and deployed, if this work is awarded to them. The bidder should submit valid lease agreement within 7 days of the award of the contract.

PQ-4 : Assessment of Site Conditions

The bidder will be disqualified if the annualized concurrent commitments of the bidder plus annualized estimated value of the work under consideration exceeds 4 times the average annual turnover of the preceding 3 years. 2. The Company however reserves the right to terminate the contract without assigning any reason whatsoever by giving two weeks' notice and no claim for any loss or damage or compensation for such termination of contract shall be payable by the Company or maintainable against the Company.

For excavation, collection and transportation of mineral sand from different mining sites/locations of Ayanivelikulangara sites to stockyard of Ayanivelikulangara spiral plant and mechanical loading, transportation and levelling of tails sand from Ayanivelikulangara spiral plant area to excavated pits of Ayanivelikulangara,

1. The period for excavation, collection and transportation of mineral sand from different mining sites Ayanivelikulangara sites to stockyard of Ayanivelikulangara spiral plant and mechanical loading, transportation and levelling of tails sand from Ayanivelikulangara spiral plant area to excavated pits of Ayanivelikulangara, is 2 months from the date of handing over of the spiral plant erected at Ayanivelikulangara to contractor as mentioned in clause no.17.2.5

2. The Company however reserves the right to terminate the contract without assigning any reason whatsoever by giving two weeks' notice and no claim for any loss or damage or compensation for such termination of contract shall be payable by the Company or maintainable against the Company.

For the transportation of spiral output from Spiral plant erected at Ayanivelikulangara to IREL,Chavara & tails sand transportation from IREL,Chavara, to excavated pits of Ayanivelikulangara

1. The period for the transportation of spiral output from Spiral plant erected at Ayanivelikulangara to IREL,Chavara & tails sand transportation from IREL,Chavara, to excavated pits of Ayanivelikulangara is 75 days from the date of handing over of the spiral plant erected at Ayanivelikulangara to contractor as mentioned in clause no.17.2.5 .
2. The Company however reserves the right to terminate the contract without assigning any reason whatsoever by giving two weeks' notice and no claim for any loss or damage or compensation for such termination of contract shall be payable by the Company or maintainable against the Company.

All other terms and conditions mentioned in the tender document shall be applicable.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
