1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. 1. Generic

- The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

2. Buyer Added Bid Specific ATC

1) Exemption from Applicability of MSME / Start Up Preference:

This job is the core activity of the company and any delay / non performance shall result in shutdown of entire operation. Hence as per OM No.F-20/2/2014-PPD(Pt.) of DoE, Ministry of Finance dated 20.09.2016 para 3, all relaxation clause of the General Instruction for Start Up and MSE's Stands suspended.

2) PRE-QUALIFICATION CRITERIA

(i) Interested bidder should meet the following minimum pre-qualification criteria:

Technical Competence :

- (a)** Bidders should be experienced in having successfully executed **similar works** as detailed below in any Public Sector Undertaking, Central / State Government or reputed private organizations during last **Seven (7) years ending Sept 2023** and meeting the value requirement as below:

Execution of at least one order for "similar work for a value of not less than **Rs 4800.00 Lakhs**"

OR

Execution of two orders for "similar works for a value each not less than of **Rs 3000.00 Lakhs**"

OR

Execution of three orders for "similar works for a value each not less than of **Rs 2400.00 Lakhs**."

Definition of Similar work(s): Similar works means works involving bulk handling/ transportation of sand/ minerals/ ores/over burden/clay or material of similar nature by using heavy earth moving equipments in a mine/ plant / Civil Construction Work.

Party shall submit work order copies along with completion / satisfactory performance certificate.

(b) Capacity Competence:

Party should have minimum 8 nos of crawler mounted excavator of min 0.9 M³ capacity and minimum 4 nos of tyre mounted Wheel Loaders of min.1.5 M³ in their own name or through lease whose Manufacturing date is later than 01/07/2019. Documentary proof of the same to be uploaded.

(c) Financial Soundness :

- Average Financial turn over during **last three years ending March 2023** shall not be less than **1803 Lakhs**. Financial Statements / Annual report containing balance sheet and statement of profit & loss account /Turn over duly certified by chartered accountant whose UDIN to be mentioned in the certificate for the above periods is to be submitted. In case of Public/ Private Limited companies, Published annual accounts will be accepted.

- The net worth of the bidder should be positive during the F.Y preceding the year of submission of bid.

- Working capital of the bidder for the financial year preceding the year of submission of bid should be 10 crores, including credit limit, if any, issued to the bidder from any nationalized bank.

(d) Concurrent Commitment

The bidder has to submit complete list of concurrent commitments on all jobs under execution by them, as per format given below, which will be taken into account to assess the spare capacity available with the bidder. If the annualized concurrent commitments of the bidder plus annualized estimated value of the work exceeds four times the average annual financial turnover during the last three financial years of the bidder, then the bid of such a bidder shall not be considered for further evaluation. Concurrent commitment of the bidder shall be evaluated as on the day of participating in the bid, based on the confirmation/declaration of the bidders that they have disclosed all works being executed by them. Bidders shall exclude all stalled project for which there is no progress in last one year giving reason for no progress considering above cut-off date. In case any adverse report/complaint are received against bidder and on enquiry found correct, offer shall be rejected and bidder shall be liable for appropriate legal action.

Documents against the Pre-qualification criteria as above complete in all respect must be uploaded. Failure to compliance of above shall make the bid incomplete and as such it shall be rejected.

3) Bidder having supervisory staff in their payroll with minimum required qualification for supervising open cast Mining operations will be preferred.

4)Note: As per para 7.3.5 on (Clarification of Bids/Shortfall Documents) of the Manual for Procurement of Goods 2017, issued by Ministry of Finance, Department of Expenditure, During evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be given asking the tenderer to respond by a specified date. If the tenderer does not comply or respond by the date, his tender will be liable to be rejected. Depending on the outcome, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or permitted. No post bid clarification at the initiative of the bidder shall be entertained. **The shortfall information / documents should be sought only in case of historical documents which pre-exist**

ed at the time of the tender opening and which have not undergone change since then. So far as the submission of documents is concerned with regard to qualification criteria, after submission of the tender, only related shortfall documents should be asked for and considered. **For example, if the bidder has submitted a supply order without its completion / performance certificate, the certificate can be asked for and considered. However, no new supply order should be asked for so as to qualify the bidder.**

5) As per section 7.3.1 of Manuals for procurement of Goods, the offer shall be declared as unresponsive and be ignored during the initial scrutiny if:

- i) The offer is not in the prescribed format or is unsigned or not signed as per the stipulations in the bid document.
- ii) The required EMD has not been provided or exemption from EMD is claimed without acceptable proof of exemption;
- iii) The bidder is not eligible to participate in the bid as per laid down eligibility criteria (example: the tender enquiry condition says that the bidder has to be a registered MSE unit but the tenderer is a, say, a large scale unit);
- iv) The tenderer has quoted for goods manufactured by a different firm without the required authority letter from the proposed manufacturer.
- v) The bid departs from the essential requirements specified in the bidding document (for example, the tenderer has not agreed to give the required performance security); or
- vi) Against a schedule in the list of requirements in the tender enquiry, the tenderer has not quoted for the entire requirement as specified in that schedule (example: in a schedule, it has been stipulated that the tenderer will supply the equipment, install and commission it and also train the purchaser's operators for operating the equipment. The tenderer has, however, quoted only for supply of the equipment).

6) SD / EPBG: Please furnish Security Deposit (SD) @ 5% of the total order value (Excluding GST) within 14 days of receipt of this order in the form of demand draft / RTGS. Alternatively, you may furnish an irrevocable Bank Guarantee for the said amount. The BG should be issued by SBI including its subsidiaries or Nationalized Bank or any schedule 'A' Commercial Bank approved by RBI. BG given by Co-Operative banks will not be accepted. BG shall not bear any interest and is liable to be forfeited for unsatisfactory completion or abandonment of the supply. 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
