- 1. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

PRE-QUALIFICATION CRITERIA

- 1. Bidders shall have successfully executed similar work during last five years from the date of tender an d the same shall be as mentioned below:
 - a. Tenderer should have executed three similar works costing not less than ₹4,42,134/-.

or

b. Tenderer should have executed two similar works costing not less than ₹5,52,668/-.

c. Tenderer should have executed one similar work costing not less than ₹8,84,268/-

The bidders shall submit the copy of the work order executed and work completion certificate for the work from their customers to whom they have provided the manpower in the last 5 years.

Similar works means: Engagement of manpower for Miscellaneous works or Data Entry Work.

2. <u>Financial</u>: Average annual financial turnover of the tenderer during the financial year 2019-20, 2020-21 , 2021-22 should be minimum ₹3,31,601/-.

- 2. Security Deposit (SD)

The successful Contractor shall furnish a Security Deposit amounting to 3% of the total value of the contract within 21 days of placement of order or before commencement of work whichever is earlier.

The Security Deposit may be remitted in the following forms:

- (i) Through NEFT/ RTGS in favour of M/s. IREL (India) Limited, Manavalakurichi.
- (ii) Irrevocable Bank Guarantee from any Scheduled / Nationalised bank acceptable to M/s. IREL (India) Limited as per annexure II.

The Security Deposit shall be for the due and faithful performance of the contract and shall remain binding notwithstanding such variations; altera tions or extensions of time as may be made, given conceded or agreed to between the contractor and M/s. IREL (India) Limited under the General C onditions or otherwise.

The security Deposit furnished by the successful tenderer shall not carry any interest whatsoever.

EMD may be adjusted towards SD. However, if EMD is submitted in the form of Bank Guarantee, fresh Bank Guarantee is to be submitted towards SD in the prescribed format as per annexure II.

3. Earnest Money Deposit (EMD)

- 3.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the f ormat given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.
- 3.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 3.6 The EMD is liable to be forfeited if:
 - (i) The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the date of opening.
 - (ii) The tenderer fails to accept the order when placed or fails to commence s upplies/works after accepting the order.
 - (iii) In case bidder submits false/fabricated documents.
 - (iv) In case bidder fails to submit SD within 30 days of receipt of work/supply o rder.
- 3.7 PSU, State Govt. Undertakings are exempted from payment of EMD. MSME /SSI u nits are exempted from payment of **EMD** provided they submit valid MSME/ NSI C certificate along with commercial bid and to ensure that certificate pertains to t he class of item/works for which floated.

4. Payment Terms

Payment will be made once in a month for the engagement of persons on pro-rata basis, against the bill duly certified by Engineer-in -charge subject to deduction of tax at source as applicable.

Payment shall be done within 30 days of submission of bill duly certified by Engineer -In-Charge.

GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the CGST/S GST Act 2017, Section 20 of the IGST Act, 2017 and Section 21 of the UTGST Act, 2017.

5. Liquidated Damages

For delays attributable to the Supplier liquidated damages shall be levied at the rate of 0.5% per week or part thereof on the value of unfinished supply for each week of delay subject to a maximum of 5% of the total contract value. However if separate period of completion is specified for certain item of work or group of items of work at the time of issuing the order the liquidated damage can be levied accordingly for the value of the item of work or group of items of work. The Purchaser may at his option and without prejudice to any other method of recovery, deduct the amount of such damages from any

moneys in his hands due to the Contractor. The payment or deduction of such damages shall not relie ve the Contractor from his obligations to complete the work or from any other of his obligations and li abilities under the contract.

Wherever the supply / work is on turnkey or having a bearing in commissioning and performa nce of the system in total, LD shall be imposed on total value, in such cases.

6. **Period of contract**

a. The Period of contract is one year from the date of start start of work and shall start the work within 15 days from the date of work order and shall continue for a period of One year (1 year), unless it is curtailed or terminated by IREL(India) Limited. The contract m ay be extended with same terms and condition for a further period not exceeding ONE ye ar by mutual consent of IREL(India) Limited and the contractor.

7. **Penalty**

- a. The contractor shall immediately provide a competent substitute in the event of any per son leaving the site due to his / her personal reasons. The delay by the contractor in provi ding a substitute beyond one working day shall attract damages @ Rs.250/- per day (per such case) on the contractor.
- b. Compensation for interruption of service rendered, cost of materials or stores lost or da maged while carrying out the work, or cost of materials or stores not returned to this offic e on completion of work or cost of defective components, spares or tools, or towards dam age of other utility services while carrying out the work, or any claim against you for the p ayment of money arises out of or under this contract will be deducted from the monthly b ill or any other amount payable to you.
- c. In case, you fail to comply with any statutory / taxation liability under appropriate law, a nd as a result thereof this office is put to any loss / obligation, monitory or otherwise, This office will be entitled to get itself reimbursed out of the outstanding bills or the performance Security Deposit of you., to extent of the loss or obligation in monitory terms.
- d. In case, person deployed is absent on a particular day, one day wage shall be deducted.

8. Period of contract

- a. The period of contract will be for a period of one year. This can be further extended for maximum period of another one year & up to full quantity on the discretion of IREL (India) Ltd on satisfactor y performance of the contract.
- b. IREL may terminate the contract by issuing two weeks' notice without assigning any reasons. Fur ther the contract may also be terminated by IREL during the subsistence of the contract if any of the terms and conditions of the contract is not complied with by the contractor.
- c. If more than one bidder quotes same L-1 price, i.e., in case a tie exists between two or more bid ders on quoted price, preference will be given to bidder as mentioned below. (L-1 party will be fin alized based on the following sequence of priorities.)
- if more than one bidder of L-1 price exists, Run for L-1 method from GeM po rtal will be adopted.

9. PENALTY

The contractor has to engage 2 (Two) persons per day on all working days failing which penalty shall be imposed @ Rs 400 /- per day per person.

10. In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall gov ern.

11. MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be don e as per GeM provisions only and IREL (India) Limited shall not be anyw ay held responsible.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
