2. 3. **1. Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

**2. Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

**PQ1: Prior Experience Criteria:**

The bidder should be an experienced service provider for Excavation, collection, loading, transportation and delivering of mineral sand OR any sand from mining areas to designated sites OR Mechanical loading, transportation & leveling of tails sand OR any sand.

**PQ-2: Prior Turnover Criteria:**

The average annual turnover of the bidder for the last three consecutive financial years ending on 31st March 2024 shall be at least Rs.1,14,00,000/- (30% of estimated value excluding GST)

The bidder will be disqualified if the annualized concurrent commitments of the bidder plus annualized estimated value of the work under consideration exceeds 4 times the average annual turnover of the preceding 3 years. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
