2. #### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

The bidder will be disqualified if the annualized concurrent commitments of the bidder plus annualized esti mated value of the work under consideration exceeds 4 times the average annual turnover of the precedin g 3 years. The bidder shall submit financial standing through latest Income Tax return (ITR)/ Audited Annu al report containing balance sheet and statement of profit & loss account for the relevant periods.
