Bidder shall be executed minimum one similar works to any Central/State Govt. Departments/ PSUs during the last seven years ending 31.12.2024. Documentary evidences such as order copy, Tax invoice copy/ completion certificate issued by authorized signatory shall be furnished along with the offer

Definition of similar works: Installation & commissioning of Electrical panels/ any Electrical works.

Note: All specifications, terms and conditions mentioned in the "Buyer Specification Document" are applicable to this bid.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
