1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. 2. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

  1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

  3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

#### PRE-QUALIFICATION CRITERIA

The tenderer should be submit the following towards Pre-Qualification Criteria:

1. The Bidders should have minimum 7 years of experience in successfully completing Housekeeping/Toilet Cleaning works or similar works during the past 7 years ending 28.02.2025. Copies of the Work order and Invoice/ Work completion certificate in support of the work undertaken by them shall be submitted in this regard.

Definition of similar works: Similar works means works involving rooms/ toilet cleaning works in a building.

2. Three similar completed works costing not less than the amount equal to 40% of the estimated contract

value (incl.GST).

3. The interested Bidder should have an Office facility within 50 Kms. radius from IREL Chavara, Kollam, Kerala OR an Undertaking shall be submitted in Rs. 200/- stamp paper attested by Notary stating that the Bidder will set up a Site Office within 50Kms of IREL Chavara, Kollam, Kerala within 14 days in case of receipt of Work Order. The bidder having Office facility as indicated above shall submit copy of any utility bill having the said Office address that is not older than two months as evidence in this regard. The Bidders can also submit Rent/Lease agreement, if the office is situated in leased/rented land.

4. The average annual turnover of the bidder for the last three consecutive years ending on 31.03.2024 shall not be less than 30% of the estimated contract value (excl.GST). In proof of the same the bidder shall submit an Audited P&L Statements return for the years 2021-22, 2022-23 & 2023-24 for verification. Alternatively GST Return may be also submitted.

Note:

1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be considered under any circumstances.

2. Pre-qualification Criteria can be relaxed for MSEs and start-up companies subject to meeting quality and technical specification. Party has to submit necessary documents for the same.

3. The offers of the bidders who have defaulted in the past in execution of the contracts or in complying with the obligations as per the contract shall not be considered.

Bids meeting PQ-1, PQ-2 & PQ-3 only will be considered for further processing (subject to meeting other Technical and Commercial conditions specified in the tender).
