- 1. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

PRE-QUALIFICATION CRITERIA

The tenderer should be submit the following towards Pre-Qualification Criteria:

1. The Bidders should have minimum 7 years of experience in successfully completing Housekeeping/Toilet Cleaning works or similar works during the past 7 years ending 28.02.2025. Copies of the Work order and Invoice/ Work completion certificate in support of the work undertaken by them shall b e submitted in this regard.

Definition of similar works: Similar works means works involving rooms/ toilet cleaning works in a building.

2. Three similar completed works costing not less than the amount equal to 40% of the estimated contract

value (incl.GST).

- 3. The interested Bidder should have an Office facility within 50 Kms. radius from IREL Chavara, Kollam, Ke rala OR an Undertaking shall be submitted in Rs. 200/- stamp paper attested by Notary stating that the Bi dder will set up a Site Office within 50Kms of IREL Chavara, Kollam, Kerala within 14 days in case of receip t of Work Order. The bidder having Office facility as indicated above shall submit copy of any utility bill having the said Office address that is not older than two months as evidence in this regard. The Bidders can also submit Rent/Lease agreement, if the office is situated in leased/rented land.
- 4. The average annual turnover of the bidder for the last three consecutive years ending on 31.03.2024 sh all not be less than 30% of the estimated contract value (excl.GST). In proof of the same the bidder shall su bmit an Audited P&L Statements return for the years 2021-22, 2022-23 & 2023-24 for verification. Alternat ively GST Return may be also submitted.

Note:

- 1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be conside red under any circumstances.
- 2. Pre-qualification Criteria can be relaxed for MSEs and start-up companies subject to meeting quality and technical specification. Party has to submit necessary documents for the same.
- 3. The offers of the bidders who have defaulted in the past in execution of the contracts or in complying wi th the obligations as per the contract shall not be considered.

- 11. Creating bid for items from irrelevant categories.

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
