### 1. PRE QUALIFICATION CRITERIA FOR FABRICATION AND SUPPLY OF ROLLERS, IDLERS AND ADJUSTING BOLTS

#### 1. Technical Criteria:

- a) The tenderer should be a manufacturer or fabricator for carrying out fabrication work as per drawings. The manufacturer should submit self-declaration towards being manufacturer / fabricator or submit Udyam certificate indicating the nature of business.
- b) The tenderer shall submit copies of purchase / work order for fabrication items to any Central / State Govt. / Public Sector Undertaking / Private organization during last 7 years ending April'2024 with the following criteria:
  - i) Work order / PO value not less than Rs 12.32 lakhs (incl. taxes) in single order.
  - ii) Work order / PO value not less than Rs 7.70 lakhs (incl. taxes) each in two orders.
  - iii) Work order / PO value not less than Rs 6.16 lakhs (incl. taxes) each in three orders

Definition of Similar Work : Fabrication & Supply of fabricated items as per drawing

Documents to be submitted:

Documentary evidence to be furnished towards supply of similar items:

- a) Copies of the work order,
- b) Copy of Invoice against the order / Satisfactory performance certificate

#### 2. Financial Criteria :

The average annual turnover of the bidder for the last three consecutive financial years ending on 31st March 2024 shall be at least Rs 3.91 lakhs.

Documents to be submitted : Bidder shall submit copies of signed & sealed audited P&L statement with auditor's membership number / IT returns for the relevant periods, for verification of the above. If audited financials/IT returns of FY 2023-24 are not available, then revenue from operations of FY 2020-21, FY 2021-22 & FY 2022-23 shall be considered.

In case the date of constitution/incorporation of the bidder is less than three year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criterion.

If financial details are not submitted for any of the year, the turnover will be calculated by dividing the total turnover as per the submitted documents by three.

3. The tenderer who had either not executed the work / supply or defaulted against IREL orders in past 5 years shall not be considered for participation in the tender.

Bids qualifying all of the above PQ criteria will only be considered for price bid opening subject to meeting technical & commercial requirements specified in the tender

4. The specifications, Terms and conditions specified in the 'Buyer specification Document' is applicable to this bid

## Disclaimer/अस्वीकरण

4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
