#### 1. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

#### 2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

#### 3. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

#### 4. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

i) The Seller fails to comply with any material term of the Contract.

ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.

iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.

iv) The Seller becomes bankrupt or goes into liquidation.

v) The Seller makes a general assignment for the benefit of creditors.

vi) A receiver is appointed for any substantial property owned by the Seller.

vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

#### 5. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

#### 6. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

#### 7. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

#### 8. Warranty

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

#### 9. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1) <u>Technical competency</u>: a)The Bidder or its OEM {themselves or through re-seller(s)} should have successfully executed **supply of electrical items for a value of Rs 50,000/- during last Five (5) years ending bid openi ng date** to any Central / State Govt. Organization / PSU / Public Listed Company / private organizations. You shall up load documentary evidence in support of the above from concerned authority / department / organization towards s upplies executed like copy of Purchase Order along with proof of delivery (like tax invoice / CRAC / E-way bills etc ) / satisfactory performance of the same.

b)Bidder should clearly understood the specification is available in ATC with bid and upload the same with sign & se al along with bid, otherwise offer will be rejected

**NB:** (i)For MSE & Start-up bidders, past experience is relaxed. However, bidders have to establish their technical co mpetency by submitting supporting documents towards successful execution of similar work **for any value**, failure t o which the offer will not considered for evaluation.

(ii) Bidder should take necessary care to upload the price CST along with "Financial Bid". Disclosing of price CST bef ore financial bid opening will liable for rejection of offer.

(iii) Bidder shall quote for all BOQ items of this bid, otherwise offer shall be rejected.

#### 2. Note:

As per para 7.3.5 on (Clarification of Bids/Shortfall Documents) of the Manual for Procurement of Goods 2017, issu ed by Ministry of Finance, Department of Expenditure, During evaluation and comparison of bids, the purchaser may , at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be given asking the t enderer to respond by a specified date. If the tenderer does not comply or respond by the date, his tender will be lia ble to be rejected. Depending on the outcome, such tenders are to be ignored or considered further. No change in p rices or substance of the bid shall be sought, offered or permitted. No post bid clarification at the initiative of the bid der shall be entertained. **The shortfall information / documents should be sought only in case of historical documents which pre-existed at the time of the tender opening and which have not undergone change since then. So far as the submission of documents is concerned with regard to qualification criteria, after submissi on of the tender, only related shortfall documents should be asked for and considered.
