The bidder should have successfully carried out similar work/s in the last seven years ending on 31.05.2024 in any Govt.Dept / PSUs/Reputed Private Organization. In proof of the same, copies of work order/s and completion certificate/s or invoice/s shall be submitted for verification. Accordingly the bidder should have executed :

The bidder will be disqualified if the annualized concurrent commitments of the bidder plus annualized estimated value of the work, excl. taxes, under consideration exceeds 4 times the average annual turnover of the preceding 3 years.
