- 1. #### 4.6. The EMD is liable to be forfeited if:

The SD shall not bear any interest and is I iable to be forfeited for unsatisfactory completion or on abandonment of the supp ly order. The EMD can be adjusted towards Security Deposit. However, if EMD is submitted in the form of BG, fresh BG is to be submitted towards SD in the prescr ibed format as per tender. If the Supplier fails to provide the security deposit with in the period specified, such failure shall constitute a breach of the Contract and I REL shall be entitled to make other arrangements for the repurchase of the store s contracted for at the risk and expense of the supplier and/or to recover from the supplier the damages arising from such cancellation.

# 6. Payment terms

# 7. Liquidated Damages

Subject to Article -25, if the SELLER fails to deliver any or all of the GOODS or perf ormance the services within the time period (s) specified in the CONTRACT, the PU RCHASER shall, without prejudice to his other remedies under the CONTRACT, ded uct from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

# **Deductions shall apply as per following formula**

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores delive red late, for each week or part thereof of delay. The total damages shall not exceed 10 (Ten) per cent of the value of delayed goods. The LD cannot exceed the amount stipulated in the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value sha Il be reduced proportionately for the delay and payment shall be released accordingly.

In the event the invoice value is not reduced proportionately for the delay, the PU RCHASER may deduct the amount so payable by SELLER, from any amount falling due to the SELLER or by recovery against the Performance Guarantee. Both seller and PURCHASER agree that the above percentages of price reduction are genuine preestimates of the loss/damage which the PURCHASER would have suffered on a ccount of delay/breach on the part of the SELLER and the said amount will be pay able on demand without there being any proof of the actual loss/or damage cause d by such breach/delay. A decision of the PURCHASER in the matter of applicabilit y of price reduction shall be final and binding.
