1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be

exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

PRE QUALIFICATION CRITERIA

The bidder should submit the following towards Pre-qualification Criteria:

1. The bidder should be a Manufacturer or dealer of TATA / MAHINDRA / ASHOK LEYL AND, for which the OEM / Dealership Certificate should be produced.

Note:

- 1. In the absence of receipt of documents meeting to Pre-qualification criteria, the off er will not be considered under any circumstances.
- 2. Relaxation in prior turnover and prior experience shall be given to MSEs / Start-up s (as defined by Department of Industrial Policy and Promotion) as per Governmen t Circular / Guidelines subject to meeting of quality and technical Specification.
- 3. The offers of the bidders who have defaulted in the past in execution of the contra cts or in complying with the obligations as per the contract shall not be considered
- 4. Traders/ distributors/ sole agent/ Works Contract are excluded from the p urview of the Procurement Policy for Micro and small Enterprises, 2012 (a s amended time to time).

Other Terms & Conditions

3. Delivery Period

Delivery shall be completed within 30 days from the date of issue of purchase ord er.

4. Earnest Money Deposit (EMD)

- 4.1. Rs.69,877/- (Rupees Sixty nine thousand eight hundred and seventy seven only)
- 4.2. Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limite d, Manavalakurichi.
- 4.3. Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. T he E-mail should contain full postal address of the Tenderer, Tender No. for which EMD & TDC were paid, payment details including amount, and UTR No. and bank details from which payment was done. - 4.4. Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the f ormat given in the tender. The Original BG shall reach this office at least 3 days i n advance from the date of opening of Techno-Commercial Bid.
- 4.5. Offers without EMD or valid EMD exemption certificate shall not be considered.
- 4.6. The EMD is liable to be forfeited if:
 - i. The tenderer changes the terms and conditions or prices or withdraw his qu otation subsequent to the date of opening.
 - ii. The tenderer fails to accept the order when placed or fails to commence sup plies/works after accepting the order.
 - iii. In case bidder submits false/fabricated documents.
 - iv. In case bidder fails to submit SD within 30 days of receipt of work/supply ord er.
 - 4.7. PSU, State Govt. Undertakings are exempted from payment of EMD subject t o request and approval. MSME /SSI units are exempted from payment of EM D/ TDC provided they submit valid MSME/ NSIC certificate along with comme rcial bid and to ensure that certificate pertains to the class of item/works for w hich floated.

5. Security Deposit (SD) (For supply orders above ₹ 5 Lakhs)

The successful tenderer has to submit Security Deposit **@5% of the contract va lue** in the form of RTGS/NEFT/ BG within 21 days of receipt of our PO as security f or satisfactory completion of the order. The SD shall not bear any interest and is I iable to be forfeited for unsatisfactory completion or on abandonment of the supp ly order. The EMD can be adjusted towards Security Deposit. However, if EMD is submitted in the form of BG, fresh BG is to be submitted towards SD in the prescr ibed format as per tender. If the Supplier fails to provide the security deposit with in the period specified, such failure shall constitute a breach of the Contract and I REL shall be entitled to make other arrangements for the repurchase of the store s contracted for at the risk and expense of the supplier and/or to recover from th e supplier the damages arising from such cancellation.

6. Payment terms

Our standard payment term is 100% payment within 30 days from the date of re ceipt and acceptance of materials along with all relevant documents" **NO advan ce payment shall be made under any circumstances**. Interest @ 12% shall be considered for evaluation of bids in case of supplier(s)/contractor(s) requesting for payment earlier than our stipulated terms.

GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the CGST/S GST Act 2017, Section 20 of the IGST Act, 2017 and Section 21 of the UTGST Act, 2017.

7. Liquidated Damages

Subject to Article -25, if the SELLER fails to deliver any or all of the GOODS or perf ormance the services within the time period (s) specified in the CONTRACT, the PU RCHASER shall, without prejudice to his other remedies under the CONTRACT, ded uct from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT P RICE, including subsequent modifications.

Deductions shall apply as per following formula

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores delive red late, for each week or part thereof of delay. The total damages shall not exceed 10 (Ten) per cent of the value of delayed goods. The LD cannot exceed th e amount stipulated in the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value sha II be reduced proportionately for the delay and payment shall be released accordingly.

In the event the invoice value is not reduced proportionately for the delay, the PU RCHASER may deduct the amount so payable by SELLER, from any amount falling due to the SELLER or by recovery against the Performance Guarantee. Both seller and PURCHASER agree that the above percentages of price reduction are genuine preestimates of the loss/damage which the PURCHASER would have suffered on a ccount of delay/breach on the part of the SELLER and the said amount will be pay able on demand without there being any proof of the actual loss/or damage cause d by such breach/delay. A decision of the PURCHASER in the matter of applicabilit y of price reduction shall be final and binding.

In case of any discrepancy between GeM GTC and Buyer ATC, terms stipulated un der buyer ATC shall govern.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
