##### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

##### 2. Buyer Added Bid Specific ATC

#### **PRE-QUALIFICATION CRITERIA**

**The bidder should submit the following towards pre-qualification criteria.**

- The tenderer must have experience in successful completion of similar works during the last 7 years ending 31.05.2024 and the same should be either of the following:
  - Three similar works costing not less than Rs. 28.73 lakhs each OR
  - Two similar works costing not less than Rs. 35.91 lakhs each OR
  - One similar work costing not less than Rs. 57.45 lakhs.

Copies of the work orders and completion certificate executed shall be enclosed along with the offer.

**Similar work:** "Transportation of any Cargo between any two places in India for a minimum one-

way distance of 1000 kms by road.”

2. Pre-qualification criteria complete in all respect must be submitted with due superscription as to **“PQC FOR TRANSPORTATION OF MONAZITE”** shall be included in the Techno-commercial Bid.
3. The tenderer who meets the above Pre-Qualification criteria only will be considered for further evaluation and recommendation.
4. Techno-commercial bids of the tenderers whose bids do not fulfill the Pre-qualification criteria will be rejected and their price bids will not be opened.
5. The tenderer’s average annual financial turnover during the last 3 years ending 31.03.2023 should be at least Rs. 22.77 lakhs. **(Attested proof of P & L statement of the company by a duly verified by statutory auditor or duly filed income tax return).**

**Note:**

1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be considered under any circumstances.
2. Relaxation in prior turnover and prior experience shall be given to MSEs / Start-ups (as defined by Department of Industrial Policy and Promotion) as per Government Circular / Guidelines subject to meeting of quality and technical Specification.
3. The offers of the bidders who have defaulted in the past in execution of the contracts or in complying with the obligations as per the contract shall not be considered.
4. **Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the Procurement Policy for Micro and small Enterprises, 2012 (as amended time to time).**

**2.0 Earnest Money Deposit (EMD)**

**2.1** Rs.1,43,640/- (Rupees One lakh forty three thousand six hundred and forty only)

**2.2** Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limited, Manavala kurichi.

**2.3** Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. The E-mail should contain full postal address of the Tenderer, Tender No. for which EMD & TDC were paid, payment details including amount, and UTR No. and bank details from which payment was done. **2.4** In case tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.

**2.5** Offers without EMD or valid EMD exemption certificate shall not be considered.

**2.6** The EMD is liable to be forfeited if:

- i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the date of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.

**2.7** PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. MSME /SSI units are exempted from payment of **EMD/ TDC** provided they submit valid MSME/ NSIC certificate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floated.

### **3.0 SECURITY DEPOSIT (SD),**

3.1. Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards satisfactory completion of the order/works as under:

- a. For works contract valued more than Rs.2 lakhs.
- b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (DLP).

3.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guarantee issued/ confirmed from any Scheduled Commercial Banks in India' or online payment to be confirmed sharing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender.

3.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalised Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.

3.4. EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Guarantee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers cheque is to be submitted towards SD.

3.5. The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on abandonment of the supply/ work order.

### **4.0 Payment Terms**

The payment for the transportation work will be made within 30 days by IREL (India) Ltd., OSCOM after delivery of Monazite cargo at destination against your bills for each load duly certified by our company officials, subject to deduction of tax at source as applicable. Applicable G.S.T will be paid directly to the Government by IREL (India)Ltd. Hence no G.S.T shall be paid by the contractor.

All payments are subject to deduction of tax at source as applicable.

GST Law mandates Tax Deduction at Source (TDS) vide section 51 of the CGST/SGST act 2017, section 20 of the IGST act 2017 and section 21 of the UTGST act 2017.

Our GSTIN 33AAAC12799F1ZL and SAC code of service is to be mentioned in the bills.

All the payment will be done only through e-payment. Hence, you have to provide your name, account no., name of the bank, and nature of account (savings/current/CC/OD), IFSC, branch code and cancelled check along with invoice.

## **5.0 LIQUIDATED DAMAGES FOR DELAYED EXECUTION OF CONTRACT:**

If the Service Provider fails to perform the services within the time period(s) specified in the CONTRACT, the EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liquidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

### **Deductions shall apply as per following formula:**

Half percent (0.5%) of the contract value per week of delay subject to a maximum of ten percent (10%) of contract value.

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling due to the Service Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agree that the above percentages of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be final and binding.

- 6.0 Completion Period:** Within 12 months from the date of the start of work order or transportation of 1800 MT of Monazite from IREL, Manavalakurichi to IREL OSCOM whichever is earlier. It is open to IREL to terminate the contract without assigning any reason or reasons by giving two weeks notice and no claim for any loss or damage or compensation for such terminations of contract shall be payable by IREL or maintainable against IREL. Firms, companies or other body corporate, submitting the tender should attach with the tender a duly certified copy of the authority of the person signing the tender to bind the firm, Company or body corporate as the case may be for fulfilling the contract.

If the performance of the contractor is found unsatisfactory, the contract is liable to be terminated on 15 days notice by us. If there is breach of all or any of the terms of the contract we may, at our sole discretion, revoke the contract and forfeit the security amount deposited by the contractor and also proceed against the contractor for recovery of such loss or damage as we may sustain as a result of such breach on the contractor's part. Company will not guarantee for any quantity within the period of contract. However contractor shall be bound to undertake lesser quantity or excess quantity during the above contract period on the same rate, terms and conditions.

- 7.0 Period of Contract:** The period of contract is one year from the date of start of work or completion of transportation of 1800 MT, whichever is earlier. This can be further extended for a maximum period of another one year for maximum of another 1800 MT on mutual agreement of both the parties on satisfactory performance of the contract.

If the entire quantity could not be transported within one year from the date of start of work due to reasons attributed to IREL, the period of contract can be further extended for a maximum period of another one year for the balance quantity on mutually agreeable basis of IREL and the successful bidder. The work is to be started within 3 days from the date of intimation received from IREL. It is open to IREL to terminate the contract without assigning any reason or reasons by giving two weeks notice and no claim for any loss or damage or compensation for such terminations of contract shall be payable by IREL or maintainable against IREL.

- 8.0** In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall govern.



**9.0** In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.

**10.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Limited shall not be anyway held responsible.**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
