If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or

3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

If the buyer has mentioned MSE purchase preference in ATC then service provider is required to upload necessary documents for MSE purchase preference for verification by the buyer during evaluation.

**PRE QUALIFICATION CRITERIA FOR ANNUAL RATE CONTRACT (ARC) WITH RESPECT TO CANALIZATION:**

1. The tenderer should have executed Similar Works successfully in CPSUs / Central Govt. Dept. / State Govt. / Semi- Govt. / Autonomous bodies or Reputed private Organizations during last five (five) years ending September 2025.

Definition of Similar work(s): Similar works means works involving carrying out Inspection, Sampling, Testing and monitoring of cargos etc. on annual rate contract basis through experienced personnel & well equipped Laboratories.

2. The tenderer should be ISO-9001:2015 certified to carry out the activities like Inspection/sampling of cargo & commodities, pre-shipment inspections, consumer product services etc. against which they have to furnish/upload valid certificate of the same.

3. The testing laboratory should have accreditation from NABL for which they have to furnish/upload valid certificate.

4. Intending tenderer who are in approved Vendor List of IREL, Chavara Unit for the similar items are required to submit the Vendor Registration Certificate to make them eligible for participation in the tender.

The tenderer have to furnish/ Upload Copies of the Order(s) along with performance/ completion certificate satisfying above PQ.

Documents against the Pre-qualification criteria as above complete in all respect must be uploaded. Failure to compliance of above shall make the bid incomplete and as such it shall be rejected.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
