Organization / PSU / Public Listed Company or private organization. Copy of relevant contract and proof of supply to be submitted along with bid in support of quantity supplied.**

You shall upload documentary evidence in support of the above from concerned authority / department / organization towards supplies executed like copy of Purchase Order along with proof of delivery (like tax invoice / CRAC / E-way bills etc ) / satisfactory performance of the same.

The request for clarification shall be given asking the tenderer to respond by a specified date. If the tenderer does not comply or respond by the date, his tender will be liable to be rejected. Depending on the outcome, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or permitted.
