1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be

exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. However, eligible micro and small enterprises will be allowed to participate. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
- 5. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

PRE-QUALIFICATION CRITERIA

The tenderer should be submit the following towards Pre-Qualification Criteria:

a) Technical: Bidder should be M/s. Nucleonix Systems Private Limited, Hyderabad.

Note:

- 1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be considered under any circumstances.
- 2. Relaxation in prior turnover and prior experience shall be given to MSEs / Startu ps (as defined by Department of Industrial Policy and Promotion) as per Governm ent Circular / Guidelines subject to meeting of quality and technical Specification.
- 3. Works Contract are excluded from the purview of the Procurement Policy for Micr o and small Enterprises, 2012 (as amended time to time).
- 4. The offers of the bidders who have defaulted in the past in execution of the contracts or in complying with the obligations as per the contract shall not be consider ed.

OTHER TERMS & CONDITIONS

- 1.0 Bidders have to upload the following along with the Bid

2.0 Period of Contract

Service shall be attended within 30 days from the date of order.

3.0—Earnest Money Deposit (EMD)

- 3.1—Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limit ed, Manavalakurichi.
- 3.2—Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX.

- 3.3—Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.
- 3.4—Offers without EMD or valid EMD exemption certificate shall not be considered.
- 3.5—The EMD is liable to be forfeited if:
- ————i.—The tenderer changes the terms and conditions or prices or withdraw his q uotation subsequent to the date of opening.
- ————ii.—The tenderer fails to accept the order when placed or fails to commence s upplies/works after accepting the order.
- ———iii.—In case bidder submits false/fabricated documents.
- ———iv.—In case bidder fails to submit SD within 30 days of receipt of work/supply o rder.
- 3.6—PSU, State Govt. Undertakings are exempted from payment of EMD subject to r equest and approval. MSME /SSI units—are exempted from payment of EMD/ T DC provided they submit valid MSME/ NSIC certificate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floated.

4.0—SECURITY DEPOSIT (SD),

4.1—Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards—satisfactory completion of the order/works as under:

- a. For works contract valued more than Rs.2 lakhs.
- b.—For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (four teen) days after notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/contractor, including warranty obligations/ defect liability period (DLP).

- 3.2 Submission of SD/PBG, if called for in the tender can also be paid through Insura nce Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guarantee issued/ confirmed from an y Scheduled Commercial Banks in India' or online payment to be confirmed shar ing Unique Transaction Reference (UTR) to the tender inviting authority as called the for in tender.
- 3.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationa lized Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.
- 3.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Guarantee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers cheque is to be submitted towards SD.
- 3.5—The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on ab andonment of the supply/ work order.

5.0 Payment Terms

- a) Will be made against bills duly certified by Officer-In-Charge subject to deduction of income tax as per Income Tax act, if applicable.
- b) All payments are subject to deduction of tax at source as applicable.
- c) GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the CG ST/SGST Act 2017, Section 20 of the IGST Act, 2017and Section 21 of the UT GST Act, 2017.
- d) Our GSTIN33AAACI2799F1ZL and SAC code of service is to be mentioned in the bills.
- e) All payment will be done only through e-payment. Hence the contractor has to provide their name, Account number, Name of the bank, nature of account (Savings/Current/CC/OD), IFSC, Branch code and cancelled cheque along with invoice.

6.0 LIQUIDATED DAMGES FOR DELAYED EXECUTION OF CONTRACT:

If the Service Provider fails to perform the services within the time period(s) sp ecified in the CONTRACT, the EMPLOYER shall, without prejudice to his other re medies under the CONTRACT, levy Liquidated damages from the CONTRACT P RICE, a sum calculated on the basis of the CONTRACT PRICE, including subseq uent modifications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maxi mum of ten percent (10%) of contract value.

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling due to the Service Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agree that the above percentages of price reduction are genuine pre-estimates of the loss/damage which the E

MPLOYER would have suffered on account of delay/breach on the part of the Ser vice Provider and the said amount will be payable on demand without there bein g any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be final and binding.

7.0 GUARANTEE PERIOD

Minimum six months from the date of rectification / servicing.

- 8.0 In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall govern.
- 9.0 In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.
- 10.0 MSE bidders are to carefully indicate their MSE status while bidding. I n case any mistake done by the bidder, evaluation and order shall be d one as per GeM provisions only and IREL (India) Limited shall not be an yway held responsible.

- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
