- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

PRE-QUALIFICATION CRITERIA

Bidder should submit the below documents towards Pre-Qualification Criteria

1. The bidder should possess the experience of having successfully completed similar works during the la st 7-years ending on August 31, 2024. The bidder should have supplied one similar completed works each costing not less than the amount equal to Rs. 4,08,750/-.

Similar work shall mean "Supply of Rectangular Type Single Deck Vibrating screen of 4tph capacity or above to any Beach sand mineral/ Garnet sand industry".

- 2. The average annual financial turnover during the last 3 years ending on March 2023 should be at least Rs. 2,92,050. Bidder has to submit copy of balance sheet / profit & loss account statement / turnover duly certified by Statutory Auditor / IT Return.

- 4.3. Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the te nder. The Original BG shall reach this office at least 3 days in advance from the date of opening of T echno-Commercial Bid.
- 4.4. Offers without EMD or valid EMD exemption certificate shall not be conside red.
- 4.5. The EMD is liable to be forfeited if:
 - i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent t o the date of opening.
 - ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after acc epting the order.
 - iii. In case bidder submits false/fabricated documents.
 - iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.

- 5.0 Security Deposit (SD) (For supply orders above ₹ 5 Lakhs)

The successful tenderer has to submit Security Deposit **@5% of the contract value** in the form of RTGS/NEFT/ BG within 21 days of receipt of our PO as security for satisfactory completion of the ord er. The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on abandonment of the supply order. The EMD can be adjusted towards Security Deposit. However, if EMD is submitted in the form of BG, fresh BG is to be submitted towards SD in the prescribed form at as per tender. If the Supplier fails to provide the security deposit within the period specified, such failure shall constitute a breach of the Contract and IREL shall be entitled to make other arrangements for the repurchase of the stores contracted for at the risk and expense of the supplier and/or to recover from the supplier the damages arising from such cancellation.

6.0 Payment terms

- a. 70 % of the payment will be made upon receipt of the material and after inspection by EIC.
- b. 20 % of the payment will be made upon installation and performance evaluation.
- c. 10 % of the amount will be held with us for a period of one year as retention money to ascert ain the continued performance of the machine and this amount can be released upon product ion of bank guarantee.

NO advance payment shall be made under any circumstances. Interest @ 12% shall be considered for evaluation of bids in case of supplier(s)/contractor(s) requesting for payment earlier than our sti pulated terms.

7.0 Liquidated Damages

Subject to Article -25, if the SELLER fails to deliver any or all of the GOODS or performance the servic es within the time period (s) specified in the CONTRACT, the PURCHASER shall, without prejudice to his other remedies under the CONTRACT, deduct from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores delivered late, for each week or part thereof of delay. The total damages shall not exceed 10 (Ten) per cent of the value of d elayed goods. The LD cannot exceed the amount stipulated in the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value shall be reduced prop ortionately for the delay and payment shall be released accordingly.

In the event the invoice value is not reduced proportionately for the delay, the PURCHASER may ded uct the amount so payable by SELLER, from any amount falling due to the SELLER or by recovery ag ainst the Performance Guarantee. Both seller and PURCHASER agree that the above percentages of price reduction are genuine pre estimates of the loss/damage which the PURCHASER would have suff ered on account of delay/breach on the part of the SELLER and the said amount will be payable on d emand without there being any proof of the actual loss/or damage caused by such breach/delay. A d ecision of the PURCHASER in the matter of applicability of price reduction shall be final and binding.

In case of any discrepancy between GeM GTC and Buyer ATC, terms stipulated under buyer ATC shall govern.
