NOTE: As per para 7.3.5 on (Clarification of Bids/Shortfall Documents) of the Manual for Procur ement of Goods 2017, issued by Ministry of Finance, Department of Expenditure, During evaluatio n and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be given asking the tenderer to respond by a specified d ate. If the tenderer does not comply or respond by the date, his tender will be liable to be rejected.
