- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and

- 4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

PRE-QUALIFICATION CRITERIA

The tenderer should submit the following towards Pre- Qualification Criteria:

- **1.** Experience of having successfully completed similar works during last 7 years en ding 31st August 2024 and the same should be either of the following. The tende rers should produce copy of work order in support of the same with satisfactory c ompletion certificate from concerned authority/department/organization for simil ar works (documents to be submitted endorsing work experience).
 - a. Three similar works, each costing not less than Rs.2,04,015/-.

(OR)

b. Two similar works, each costing not less than Rs.2,55,019/-.

(OR)

c. One similar work, costing not less than Rs.4,08,030/-.

<u>Definition of similar works</u>: Similar works means works involving cleaning of building.

2. The bidder must have functional office established in districts of Kanyakumari / Ti runelveli / Thiruvananthapuram /Thoothukudi as on 31st August, 2024. Bidder sh all submit proof of registration of such office as per the Tamil Nadu Shops & Esta blishment Act 1947 with address proof or equivalent in Kerala State.

3. Financial:

Average annual financial turnover during the last 3 years, ending 31st March 2023, should be at least Rs.1,53,011/-. (Copies of profit & loss account and balance sheets for the last 3 years are to be submit ted) or IT return duly filed duly audited by statutory auditor.

Note:

- 1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be considered under any circumstances.
- Relaxation in prior turnover and prior experience shall be given to MSEs / Startups (as defined by Department of Industrial Policy and Promotion) as per Govern ment Circular / Guidelines subject to meeting of quality and technical Specificati on.
- 3. The offers of the bidders who have defaulted in the past in execution of the cont racts or in complying with the obligations as per the contract shall not be considered.
- 4. Traders/ distributors/ sole agent/ Works Contract are excluded from th e purview of the Procurement Policy for Micro and small Enterprises, 2 012 (as amended time to time).

OTHER TERMS & CONDITIONS

2.0 Earnest Money Deposit (EMD)

- 2.1 Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limit ed, Manavalakurichi.
- 2.2 Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. The E-mail should contain full postal address of the Tenderer, Tender No. for whi ch EMD & TDC were paid, payment details including amount, and UTR No. and b ank details from which payment was done. IREL's Email id is purchase-mk@irel.co.in
- 2.3 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.
- 2.4 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 2.5 The EMD is liable to be forfeited if:
 - i. The tenderer changes the terms and conditions or prices or withdraw his q uotation subsequent to the date of opening.
 - ii. The tenderer fails to accept the order when placed or fails to commence s upplies/works after accepting the order.
 - iii. In case bidder submits false/fabricated documents.
 - iv. In case bidder fails to submit SD within 30 days of receipt of work/supply o rder.
- 2.6 PSU, State Govt. Undertakings are exempted from payment of EMD subject to r equest and approval. MSME /SSI units are exempted from payment of EMD/ T DC provided they submit valid MSME/ NSIC certificate along with commercial bi d and to ensure that certificate pertains to the class of item/works for which floa ted.

3.0 SECURITY DEPOSIT (SD),

- 3.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards s atisfactory completion of the order/works as under:
 - a. For works contract valued more than Rs.2 lakhs.
 - b. For supply & service contract valued more than Rs.5 lakhs.
 Performance Security is to be furnished by a specified date (generally 14 (fou rteen) days after notification of the award) and it should remain valid for a pe riod of 60 (sixty) days beyond the date of completion of all contractual obligat ions of the supplier/ contractor, including warranty obligations/ defect liability period (DLP).
- 3.2 Submission of SD/PBG, if called for in the tender can also be paid through Insura nce Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guarantee issued/ confirmed from an y Scheduled Commercial Banks in India' or online payment to be confirmed shar

- ing Unique Transaction Reference (UTR) to the tender inviting authority as calle d for in tender.
- 3.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationa lized Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.
- 3.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Gu arantee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers cheque is to be su bmitted towards SD.
- 3.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on ab andonment of the supply/ work order.

4.0 LIQUIDATED DAMGES FOR DELAYED EXECUTION OF CONTRACT:

If the Service Provider fails to perform the services within the time period(s) spe cified in the CONTRACT, the EMPLOYER shall, without prejudice to his other reme dies under the CONTRACT, levy Liquidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent mo diffications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maximu m of ten percent (10%) of contract value.

EMPLOYER may deduct the amount so payable by Service Provider, from any am ount falling due to the Service Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agree that the above percenta ges of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be final and binding.

5.0 PENALTY:

Contractor should carry out the work as per the scope of works. If the contractor fails to carry out as per scope of work, a fine will be imposed at the rate of Rs.5 00/- per day each area for the period of non execution of the work.

6.0 WORKING HOURS:

Work hours shall be between **8.00 AM to 4.00 PM** on all working days, holiday s & Sunday (after allowing for formalities connected with documentation, site bri efing etc). However based on a written request from the contractor IREL (India) Limited may consider, in deserving conditions, extension of working hours beyond what is stipulated above and such extension shall be granted formally.

7.0 PERIOD OF CONTRACT:

a) The work shall be commenced within 15 **(fifteen)** days from the date of iss ue of work order. Within this period (i.e. 15 days) contractor should complet e all the statutory training i.e. Vocational Training (VT), etc. for their employ ees.

- b) The period of contract shall be **1 (one) year** from the date of commenceme nt of work.
- c) The company reserves the right to terminate the contract without assigning any reason by giving two week notice and no claim for any loss or damage or compensation for such termination of contract shall be payable by the company or maintainable against the company.

8.0 PAYMENT TERMS:

- a) Payment will be made based on mandays only. Payment for the mandays en gaged shall be done on monthly basis.
- b) The final bill, in all respect should be submitted by the contractor within 30 days from the date of completion of work.
- c) After completion of work all deposits will be released along with final bill.
- d) Payment will be made within 30 days of certification of contractor's bill by engineer-in charge/officer-in-charge.
- e) All payments are subject to deduction of tax at source as applicable.
- f) GST Law mandates Tax Deduction at Source (TDS) vide section 51 of the CG ST/SGST act 2017, section 20 of the IGST act 2017 and section 21 of the UT GST act 2017.
- g) Our GSTIN 33AAACI2799F1ZL and SAC code of service is to be mentioned in the bills.
- h) All the payment will be done only through e-payment. Hence, you have to pr ovide Your Name, Account No., Name of the bank, Nature of Account (saving s/current/CC/OD), IFSC, branch code and cancelled check along with invoice.
- **9.0** In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall g overn.
- **10.0** In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.
