- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

PRE-QUALIFICATION CRITERIA

Bidder should submit the below documents towards Pre-Qualification Criteria

- 1. Original Equipment Manufacturer (OEM) of similar items or their Associate/Authorized dealers/ agents are eligible to participate in the tender. Associate/Authorized dealers / agents are required to submit authorization letter from OEM. OEM shall furnish document & Self declaration certificate to prove that they are the manufacture the similar items.
 - Similar Items / work mean Supply of at least One Horizontal Pan Filter of minimum 5Tph capacity.
 - The bidder should have carried out one similar supply /work having value not less than **Rs.46,00,000** to any Central/ State Government, Public Sector Undertaking(s) or reputable private organizations dur ing last Seven (7) years ending 30.09.2024. In proof of the same, the bidder should submit Copy of the Purchase order, Tax Invoice / Completion Certificate and Satisfactory Performance Certificate.
- 2. Average annual financial turnover of the bidder during the last three years ending on March 2023 shou ld be minimum **Rs.33,60,000/-** Financial Statements (Audited balance sheet Profit & Loss Account/ IT Returns/ certified copy of Chartered Accountant) for the above periods shall be submitted.
- 3. Bidder should have to submit signed copy of tender document each page and Technical data sheet (A nnex-1) as a token of acceptance of all terms and condition of this tender

Note: For MSE Bidders & Start-Up Past experience is relaxed. However, bidders have to es tablish their technical competency by submitting supporting documents showing successf ul execution of similar item/work, failure to which the offer will not considered for evaluat ion.

Note:

1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be con sidered under any circumstances.

- 2. Relaxation in prior turnover and prior experience shall be given to MSEs / Start-ups (as defined by D epartment of Industrial Policy and Promotion) as per Government Circular / Guidelines subject to me eting of quality and technical Specification.
- 3. The offers of the bidders who have defaulted in the past in execution of the contracts or in complying with the obligations as per the contract shall not be considered.
- 4. Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the P rocurement Policy for Micro and small Enterprises, 2012 (as amended time to time).

4.0 Earnest Money Deposit (EMD)

- 4.2 Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limited, Manavalakurichi.

- 4.3. Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the te nder. The Original BG shall reach this office at least 3 days in advance from the date of opening of T echno-Commercial Bid.
- 4.4. Offers without EMD or valid EMD exemption certificate shall not be conside red.
- 4.5. The EMD is liable to be forfeited if:
 - i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent t o the date of opening.
 - ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
 - iii. In case bidder submits false/fabricated documents.
 - iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 4.6. PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval.

- 4.7 Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the Pr ocurement Policy for Micro and small Enterprises, 2012 (as amended time to time).

5.0 Security Deposit (SD) (For supply orders above ₹ 5 Lakhs)

The successful tenderer has to submit Security Deposit @5% of the contract value in the form of RTGS/NEFT/ BG within 21 days of receipt of our PO as security for satisfactory completion of the ord er. The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or o

n abandonment of the supply order. The EMD can be adjusted towards Security Deposit. However, i f EMD is submitted in the form of BG, fresh BG is to be submitted towards SD in the prescribed form at as per tender. If the Supplier fails to provide the security deposit within the period specified, such failure shall constitute a breach of the Contract and IREL shall be entitled to make other arrangeme nts for the repurchase of the stores contracted for at the risk and expense of the supplier and/or to r ecover from the supplier the damages arising from such cancellation.

6.0 Payment terms

- A. 70% payment of will be released within 30 days of receipt of all equipment (Fabrication, supply of Horizont al Vacuum Pan Filter) and inspection at IREL Stores with submission of relevant invoice and acceptance by the Engineer-in-Charge.
- B. 20% payment shall be made after erection and successful commissioning of the equipment.
- C. 10 % payment will be made after the Guarantee period OR against submission of a Performance BG (to be submitted after the supply and acceptance) for equivalent value (10% of the total value) valid till the end of the Guarantee period.
- D. Payment will be done within 30 days on submission of proper Invoice.

NO advance payment shall be made under any circumstances Interest @ 12% shall be consid ered for evaluation of bids in case of supplier(s)/contractor(s) requesting for payment earlier than our stipulated terms.

7.0 Liquidated Damages

Subject to Article -25, if the SELLER fails to deliver any or all of the GOODS or performance the servic es within the time period (s) specified in the CONTRACT, the PURCHASER shall, without prejudice to his other remedies under the CONTRACT, deduct from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores delivered late, for each week or part thereof of delay. The total damages shall not exceed 10 (Ten) per cent of the value of d elayed goods. The LD cannot exceed the amount stipulated in the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value shall be reduced proportionately for the delay and payment shall be released accordingly.

In the event the invoice value is not reduced proportionately for the delay, the PURCHASER may ded uct the amount so payable by SELLER, from any amount falling due to the SELLER or by recovery ag ainst the Performance Guarantee. Both seller and PURCHASER agree that the above percentages of price reduction are genuine pre estimates of the loss/damage which the PURCHASER would have suff ered on account of delay/breach on the part of the SELLER and the said amount will be payable on d emand without there being any proof of the actual loss/or damage caused by such breach/delay. A d ecision of the PURCHASER in the matter of applicability of price reduction shall be final and binding.

In case of any discrepancy between GeM GTC and Buyer ATC, terms stipulated under buyer ATC shall govern.
