1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of

quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the <u>OM No.1 4 2021 PPD dated 18.05.2023</u> for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 6. If L-1 is not an MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference for the Buyer after evaluation of submitted documents. 6. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or

3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

PRE-QUALIFICATION CRITERIA

The tenderer should submit the following towards Pre- Qualification Cr iteria:

- 1. The party shall be authorized service center for any of the Make alternators viz. Kirloskar Electric Or "S tamford" Or "Marathon" Or "Leroy Somer" Or Crompton Greaves".
- The party shall submit copies of similar Purchase order/work order along with relevant work completio n certificate/ Tax invoice for having successfully completed the work during the last 7 years ending 30^t
 ^h September 2024 should be of the following.
 - a) Tenderer should have executed three similar works each costing not less than Rs.1,92,154/-

OR

b) Tenderer should have executed two similar works each costing not less than Rs.2,40,193/-

OR

- c) Tenderer should have executed one similar work costing not less than Rs.3,84,309/-.
- i. The bidder shall submit all credentials including copies of work orders executed, work completion r eport OR commissioning report OR Performance certificate OR Tax invoice for the similar works.
- ii. Similar work means work involving rewinding and assembling of 500 KVA or higher capacity Alternator in PSU's OR CPSU's OR Government Depart ments OR Government institutions OR reputed private sector companies.
- 3. The bidder shall submit duly signed and stamped Scope of Work sheets as per our bid.
- 4. Average annual financial turnover during the last 3 years, ending 31 st of March 2023 should be at least **Rs.1,44,116/-** Documentary proof for the same shall be enclosed.

Note:

- 1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be consid ered under any circumstances.
- 2. Relaxation in prior turnover and prior experience shall be given to MSEs / Start-ups (as defined by Dep artment of Industrial Policy and Promotion) as per Government Circular / Guidelines subject to meeting of quality and technical Specification.
- **3.** The offers of the bidders who have defaulted in the past in execution of the contracts or in complying with the obligations as per the contract shall not be considered.
- 4. Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the Pro curement Policy for Micro and small Enterprises, 2012 (as amended time to time).

2.0 Earnest Money Deposit (EMD)

2.1-Rs.42,486/- (Rupees Forty two thousand four hundred and eighty six only)-

- 2.2—Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limited, Manavalakurichi.
- 2.3—Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. The E-mail should contain full postal address of the Tenderer, Tender No. for which EMD & TDC were paid, payment detailsincluding amount, and UTR No. and bank details from which payment was done. - 2.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the t ender. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.
- 2.5—Offers without EMD or valid EMD exemption certificate shall not be conside red.
- 2.6 The EMD is liable to be forfeited if:
 - i.—The tenderer changes the terms and conditions or prices or withdraw his quotation subsequen t to the date of opening.
 - ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after a ccepting the order.
- 2.7—PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. MSME /SSI units—are exempted from payment of **EMD/ TDC** provided they submit valid MSME/ NSI C certificate along with commercial bid and to ensure that certificate pertains to the class of item/wo rks for which floated.

3.0 SECURITY DEPOSIT (SD),

- 3.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (exc luding Taxes) towards satisfactory completion of the order/works as under
 - a. For works contract valued more than Rs.2 lakhs.
 - b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after no tification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligati ons/ defect liability period (DLP).

- 3.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guarantee issued/ confirmed from any Scheduled Commercial Banks in India' or online payment to b e confirmed sharing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender.
- 3.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalized Banks/ Schedul ed Commercial Banks (other than Cooperative Banks) only acceptable.
- 3.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submit ted in the form of Bank Guarantee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers cheque is to be submitted towards SD.
- 3.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfa ctory completion or on abandonment of the supply/ work order.

4.0 Payment Terms

a. 90% payment will be released within 30 days after commissioning of Alternator against your bill duly certified by our officials subject to dedu ction of taxes whichever is applicable. Performance guarantee for a peri od of one year.

- b. Balance 10% payment will be released after completion of the guarante e period or against submission of Bank Guarantee.
- c. GST Law mandates Tax Deduction at Source (TDS) vide section 51 of th e CGST/SGST act 2017, section 20 of the IGST act 2017 and section 21 of the UTGST act 2017.
- d. Our GSTIN 33AAACI2799F1ZL and SAC code of service is to be mention ed in the bills.
- e. All the payment will be done only through e-payment. Hence, you have to provide your name, account no., name of the bank, and nature of acc ount (savings/current/CC/OD), IFSC, branch code and cancelled check al ong with invoice.

5.0 Liquidated Damges For Delayed Execution Of Contract:

If the Service Provider fails to perform the services within the time period(s) specified in the CONT RACT, the EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liq uidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRI CE, including subsequent modifications.

Deductions shall apply as per following formula:

One percent (1%) of the contract value per week of delay subject to a maximum of ten percent (10%) of contract value.

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling due to t he Service Provider or by recovery against the Performance Guarantee. Both Service Provider and E MPLOYER agree that the above percentages of price reduction are genuine pre-estimates of the loss/ damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Se rvice Provider and the said amount will be payable on demand without there being any proof of the a ctual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of appl icability of price reduction shall be final and binding.

6.0 Completion Period:

Repairing of alternator and re-commissioning of alternator at our site shall be completed within 45 d ays from the date of issue of work order.

- **7.0** In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall g overn.
- **8.0** In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.
- 9.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistak e done by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Limited shall not be anyway held responsible.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
