- 1. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. #### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

## **PRE-QUALIFICATION CRITERIA**

Bidder should submit the below documents towards Pre-Qualification Criteria

#### 1.0 Technical:

- 1. The tenderer shall be a manufacturer or authorized system integrator for su pply of load cell based bin weighing system. The authorized dealer shall sub mit valid authorization certificate or bid specific authorization letter from the manufacturer.
- 2. The tenderer shall submit copies of purchase order/ work orders for fabricati on, supply, installation and commissioning of bin/ silo weighing system alon g with fabrication of bin/silo to any Central / State Govt. / Public Sector Unde rtaking / Private organization during last 15 years ending December 2023. The tenderer has to submit invoice copy/ Delivery challan along with satisfact ory completion/ performance certificate along with the bid.
- 3. Bidder should provide the copies of purchase order executed shall be submit ted:
  - a. Three similar completed supply(s) costing not less than **Rs.13,38,200/ -**OR
  - b. Two similar completed supply(s) costing not less than **Rs.16,72,750**/-OR

Similar work means "fabrication, supply, installation and commissioning of bins/silo along with load c ell based bin/ silo weighing system".

#### 2.0 Financial:

Average annual financial turnover of the bidder during the last three years ending on March 2023 sh ould be minimum Rs.10,03,650/-

Tenderer shall submit audited Annual Report for the last three years.

#### Note:

- 1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be considered under any circumstances.
- Relaxation in prior turnover and prior experience shall be given to MSEs / Startups (as defined by Department of Industrial Policy and Promotion) as per Govern ment Circular / Guidelines subject to meeting of quality and technical Specificati on.
- 3. The offers of the bidders who have defaulted in the past in execution of the cont

racts or in complying with the obligations as per the contract shall not be considered.

- 3.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.
- 3.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 3.6 The EMD is liable to be forfeited if:
  - i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the date of opening.
  - ii. The tenderer fails to accept the order when placed or fails to commence sup plies/works after accepting the order.
  - iii. In case bidder submits false/fabricated documents.
  - iv. In case bidder fails to submit SD within 30 days of receipt of work/supply ord
- 3.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to r equest and approval. MSME /SSI units are exempted from payment of EMD/ TD C provided they submit valid MSME/ NSIC certificate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floate d.

# **4.0** Security Deposit (SD) (For supply orders above ₹ 5 Lakhs)

The successful tenderer has to submit Security Deposit @5% of the contract v alue in the form of RTGS/NEFT/ BG within 21 days of receipt of our PO as securit y for satisfactory completion of the order. The SD shall not bear any interest and

is liable to be forfeited for unsatisfactory completion or on abandonment of the s upply order. The EMD can be adjusted towards Security Deposit. However, if EMD is submitted in the form of BG, fresh BG is to be submitted towards SD in the prescribed format as per tender. If the Supplier fails to provide the security deposit within the period specified, such failure shall constitute a breach of the Contract and IREL shall be entitled to make other arrangements for the repurchase of the stores contracted for at the risk and expense of the supplier and/or to recover from the supplier the damages arising from such cancellation.

#### **5.0** <u>Inspection:</u>

The fabricated product storage bins shall be inspected at Party's firm/ workshop during shot blasting and before painting to confirm the dimensions as per drawing PD 1239/E dated 02.8.2024 and workmanship. The successful bidder shall inform the fabrication process in advance for inspection by IREL official (before one week).

## **6.0** Period of work:

Fabrication, supply, installation and commissioning of the sillimanite product sto rage bin along with load cell based weighing system shall be completed within 9 0 days from the date of acceptance of work order and site clearance.

## **7.0** <u>Liquidated Damages:</u>

Any delay in executing and completing the work in excess of the period specifie d in the work order / site clearance will attract Liquidated damages @ 0.5 % per week or part thereof, subject to a maximum of 10 % of the Contract value.

## **8.0** Payment Terms:

70% payment will be released against supply of material (which includes supply of all the structural column, beams, sheets, gratings, etc., as per drawing along with load cells, brackets, panels, cables, etc.) to IREL site, 20% of supply part payment and 100% of erection, commissioning part payment will be released against completion of total commissioning of bins and calibration of the bin weighing system and balance 10 % payment of supply part after the guarantee period OR against submission of a performance Bank Guarantee for equivalent value, valid till the end of the guarantee period.

The payment will be released within 30days from the date of submission of bill d uly certified by the concern Engineer-in-charge after satisfactory completion of t he work.

#### 9.0 Liquidated Damages

Subject to Article -25, if the SELLER fails to deliver any or all of the GOODS or per formance the services within the time period (s) specified in the CONTRACT, the PURCHASER shall, without prejudice to his other remedies under the CONTRACT, deduct from the CONTRACT PRICE, a sum calculated on the basis of the CONTRA CT PRICE, including subsequent modifications.

## **Deductions shall apply as per following formula**

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores deli vered late, for each week or part thereof of delay. The total damages shall not e xceed 10 (Ten) per cent of the value of delayed goods. The LD cannot exceed the amount stipulated in the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value shall be reduced proportionately for the delay and payment shall be released acco

rdingly.

In the event the invoice value is not reduced proportionately for the delay, the P URCHASER may deduct the amount so payable by SELLER, from any amount falli ng due to the SELLER or by recovery against the Performance Guarantee. Both s eller and PURCHASER agree that the above percentages of price reduction are g enuine preestimates of the loss/damage which the PURCHASER would have suffe red on account of delay/breach on the part of the SELLER and the said amount w ill be payable on demand without there being any proof of the actual loss/or dam age caused by such breach/delay. A decision of the PURCHASER in the matter of applicability of price reduction shall be final and binding.

In case of any discrepancy between GeM GTC and Buyer ATC, terms stipulated u nder buyer ATC shall govern.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
