- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. - 4. - 5. - 4.3. Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the te nder. The Original BG shall reach this office at least 3 days in advance from the date of opening of T echno-Commercial Bid.
- 4.4. Offers without EMD or valid EMD exemption certificate shall not be conside red.
- 4.5. The EMD is liable to be forfeited if:
