1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 2. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

PQ1: Prior Experience Criteria:

The bidder should be an experienced service provider of excavation or loading and transportation or dredging or refilling of any sand or gravel or morum or boulders.

Tender stipulation on prior experience:

To meet the above experience criteria,

The bidder should have successfully completed similar service contracts during the last seven years ending 31.12.2025 meeting any of the following:

- a) Three similar completed service contracts costing not less than Rs.2,85,60,000/- (40 % of the estimated value excluding GST) or
- b) Two similar completed service contracts costing not less than Rs.3,57,00,000/-(50 % of estimated value excluding GST) or

PQ-2: Prior Turnover Criteria:

The average annual turnover of the bidder for the last three consecutive financial years ending on 31.03.2025 shall be at least Rs. 2,14,20,000/- (30% of estimated value excluding GST). In case of last financial year not being audited/certified, documents for 3 years prior to previous financial year may be submitted. If financial details are not submitted for any of the years, the turnover will be calculated by dividing the total turnover as per the submitted documents by three.

The bidder will be disqualified if the annualized concurrent commitments of the bidder plus annualized estimated value of the work under consideration exceeds 4 times the average annual turnover of the preceding 3 years. The bidder shall submit financial standing through latest Income Tax return (ITR)/ Annual report containing balance sheet and statement of profit & loss account for the relevant periods.

The bids qualifying PQ-1, PQ-2, & PQ-3 only will be considered for further processing

Period of Contract : The period of contract will be twelve (12) months from the date of commencement of the work. However, the contractor shall daily transport the total work load of the forum members present on that particular day to the Spiral Plant at VT as per the direction of Engineer-In Charge. The contractor should expeditiously settle all the local issues related to the transportation work at his risk and cost.

Payment to contractor will be made on a monthly basis within one month after submission of bills and after the work done is certified by Engineer –In Charge on the basis of the log book maintained for the purpose.

All other terms and conditions in the tender document shall be applicable.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:
