- 1. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

PRE-QUALIFICATION CRITERIA

The tenderer should submit the following towards Pre- Qualification Criteria:

1. Technical:

Tenderer should have carried out similar works of engagement of semi skilled persons in Public / Priva te Organizations in the last 3 years from the date of E-Tender starting and the same should be either of the following

a) Tenderer should have executed three similar works each costing not less th an Rs.3,38,978/-

OR

b) Tenderer should have executed two similar works each costing not less than Rs.4,23,723/-

OR

The bidder shall submit the copy of the work order and work completion certificates for the works, from their customers to whom they have provided the manpower in the last 3 years.

3. Financial:

Average annual financial turnover of the tenderer during the financial year 2020-21, 2021-22 & 2022-23 should be of minimum Rs 2, 54, 234 /-. Copy of Profit & Loss account and Balance Sheet or Income and Expenditure account has to be submitted.

- 1. In the absence of receipt of documents meeting to Pre-qualification criteria, the off er will not be considered under any circumstances.
- 2. Relaxation in prior turnover and prior experience shall be given to MSEs / Start-up s (as defined by Department of Industrial Policy and Promotion) as per Governmen t Circular / Guidelines subject to meeting of quality and technical Specification.
- 3. The offers of the bidders who have defaulted in the past in execution of the contracts or in complying with the obligations as per the contract shall not be considered
- 4. Traders/ distributors/ sole agent/ Works Contract are excluded from the p urview of the Procurement Policy for Micro and small Enterprises, 2012 (a s amended time to time).

2.0 Earnest Money Deposit (EMD)

- 2.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.
- 2.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 2.6 The EMD is liable to be forfeited if:
 - i. The tenderer changes the terms and conditions or prices or withdraw his q uotation subsequent to the date of opening.
 - ii. The tenderer fails to accept the order when placed or fails to commence s upplies/works after accepting the order.
 - iii. In case bidder submits false/fabricated documents.
 - iv. In case bidder fails to submit SD within 30 days of receipt of work/supply o rder.
- 2.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to r equest and approval. MSME /SSI units are exempted from payment of EMD/ T DC provided they submit valid MSME/ NSIC certificate along with commercial bi

d and to ensure that certificate pertains to the class of item/works for which floated.

3.0 SECURITY DEPOSIT (SD),

- 3.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards s atisfactory completion of the order/works as under:
 - a. For works contract valued more than Rs.2 lakhs.
 - b. For supply & service contract valued more than Rs.5 lakhs.
 Performance Security is to be furnished by a specified date (generally 14 (fou rteen) days after notification of the award) and it should remain valid for a pe riod of 60 (sixty) days beyond the date of completion of all contractual obligat ions of the supplier/ contractor, including warranty obligations/ defect liability period (DLP).
- 3.2 Submission of SD/PBG, if called for in the tender can also be paid through Insura nce Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guarantee issued/ confirmed from an y Scheduled Commercial Banks in India' or online payment to be confirmed shar ing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender.
- 3.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationa lized Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.
- 3.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Gu arantee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers cheque is to be su bmitted towards SD.
- 3.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on ab andonment of the supply/ work order.

4.0 Payment Terms

- a. Payment will be made once in a month for the engagement of persons on pro-rata basis, again st the bill duly certified by Engineer-in -charge subject to deduction of tax at source as applica ble.
- b. All payments are subject to deduction of tax at source as applicable.
- c. GST Law mandates Tax Deduction at Source (TDS) vide section 51 of the CG ST/SGST act 2017, section 20 of the IGST act 2017 and section 21 of the UT GST act 2017.
- d. Our GSTIN 33AAACI2799F1ZL and SAC code of service is to be mentioned in the bills.
- e. All the payment will be done only through e-payment. Hence, you have to p rovide your name, account no., name of the bank, and nature of account (sa vings/current/CC/OD), IFSC, branch code and cancelled check along with inv oice.

5.0 LIQUIDATED DAMGES FOR DELAYED EXECUTION OF CONTRACT:

If the Service Provider fails to perform the services within the time period(s) sp ecified in the CONTRACT, the EMPLOYER shall, without prejudice to his other re medies under the CONTRACT, levy Liquidated damages from the CONTRACT P RICE, a sum calculated on the basis of the CONTRACT PRICE, including subseq uent modifications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maxi mum of ten percent (10%) of contract value.

EMPLOYER may deduct the amount so payable by Service Provider, from any am ount falling due to the Service Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agree that the above percenta ges of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be final and binding.

6.0 Period of contract

The contract will be for a period twelve months (one year) from the date of commencement of work. Before commencement of work all the persons shall under go Vocational training arranged by IREL (India) Limited at contractor's cost (Training consists of 6 days of class room lectures) within 10 days from the date of is sue of work order.

7.0 Payment:

Payment will be made once in a month for the engagement of persons on proata basis, against the bill duly certified by Engineer-in -charge subject to deducti on of tax at source as applicable.

8.0 Penalty:

The successful contractor shall have to engage sufficient persons to carry out the job as per scope of work. However,

In the event of the contractor failing to deploy the required Nos of person in any day a penalty of Rs. 500 /- per person per day will be imposed for the number of days defaulted.

- **6.0** In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall govern.
- **7.0** In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.
