- 1. OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### **PRE-QUALIFICATION CRITERIA**

#### The tenderer should submit the following towards Pre- Qualification Criteria:

- 1) The tenderer shall submit copies of documentary proof towards execution of similar works during last 7 years from the date of tender as below.
  - a. Three similar completed works each costing not less than Rs.6,93,230/-

b. Two similar completed works each costing not less than Rs.8,66,538/-

<u>Definition of Similar work</u>: "Similar work" means engagement of Forklift / Earth Movin g Equipments (EME) on hired basis.

- 2. Relaxation in prior turnover and prior experience shall be given to MSEs / Startups (as defined by Department of Industrial Policy and Promotion) as per Govern ment Circular / Guidelines subject to meeting of quality and technical Specificati on.
- 3. The offers of the bidders who have defaulted in the past in execution of the contracts or in complying with the obligations as per the contract shall not be considered.
- 4. Traders/ distributors/ sole agent/ Works Contract are excluded from th e purview of the Procurement Policy for Micro and small Enterprises, 2 012 (as amended time to time).

# 1.0 Earnest Money Deposit (EMD)

- 1.1 Rs.29,374/- (Rupees Twenty nine thousand three hundred and seventy four only)
- 1.2 Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limit ed, Manavalakurichi.
- 1.3 Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. The E-mail should contain full postal address of the Tenderer, Tender No. for whi ch EMD & TDC were paid, payment details including amount, and UTR No. and b ank details from which payment was done. - 1.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.
- 1.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 1.6 The EMD is liable to be forfeited if:
  - i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the date of opening.
  - ii. The tenderer fails to accept the order when placed or fails to commence s upplies/works after accepting the order.
  - iii. In case bidder submits false/fabricated documents.
  - iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 1.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to r equest and approval. MSME /SSI units are exempted from payment of EMD/ T DC provided they submit valid MSME/ NSIC certificate along with commercial bi d and to ensure that certificate pertains to the class of item/works for which floa ted.

# 2.0 SECURITY DEPOSIT (SD),

- 2.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards s atisfactory completion of the order/works as under:
  - a. For works contract valued more than Rs.2 lakhs.
  - b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (DLP).

- 3.2 Submission of SD/PBG, if called for in the tender can also be paid through Insura nce Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guarantee issued/ confirmed from an y Scheduled Commercial Banks in India' or online payment to be confirmed shar ing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender.
- 3.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nation alized Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.
- 3.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Gu arantee, fresh Bank Guarantee in the prescribed format or demand draft / Bankers cheque is to be s ubmitted towards SD.
- 3.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on ab andonment of the supply/ work order.

## 3.0 Period of contract:

The successful contractor shall mobilize the work so as to commence the work within 21 days from t he date of issue of Work order. The period of contract will be twelve months from the date of comme ncement. IREL can utilize the balance hours if any, on the same terms and conditions of the contract based on satisfactory performance of the contractor on mutual agreement basis.

## 4.0 Penalty:

- a. In case the contractor fails to commence the work by mobilizing the equipme nt within 21 days of issue of work order, the contractor shall be liable to pay p enalty @ Rs.3000/- (Rupees two thousand only) per day for each day's delay in commencing the work.
- b. During the contract period, in case the contractor fails to provide the forklift f or work for more than two days in a month, he shall be liable to pay penalty @ Rs. 2500/- per day for each day's non deployment beyond two days. If the contractor fails to provide the forklift for a consecutive period of 15 days, the work order shall be cancelled at the risk and cost of the contractor.

#### 5.0 Payment Terms

Payment shall be made on monthly basis. 100% payment for the work executed shall be made within 30 days of submission of bill. Minimum payment shall be m ade for 3 (Three) hours a day on monthly average basis. If total operating hour in a month exceeds the total operating days multiplied by 3, then additional payment for the hours exceeded shall be made based on hourly rate quoted by the contractor.

The contractor shall submit the bills on a monthly basis to the Engineer-In charg e. All payments are subject to deduction of tax at source as applicable.

GST Law mandates Tax Deduction at Source (TDS) vide section 51 of the CGST/SGST act 2017, section 20 of the IGST act 2017 and section 21 of the UTGST act 2017.

## 6.0 LIQUIDATED DAMGES FOR DELAYED EXECUTION OF CONTRACT:

If the Service Provider fails to perform the services within the time period(s) spe cified in the CONTRACT, the EMPLOYER shall, without prejudice to his other reme dies under the CONTRACT, levy Liquidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent mo diffications.

## **Deductions shall apply as per following formula:**

Half percent (0.5%) of the contract value per week of delay subject to a maximu m of ten percent (10%) of contract value.

EMPLOYER may deduct the amount so payable by Service Provider, from any am ount falling due to the Service Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agree that the above percenta ges of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be final and binding.

- 8.0 In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall g overn.
- 9.0 In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.
- 10.0 MSE bidders are to carefully indicate their MSE status while bidding. I n case any mistake done by the bidder, evaluation and order shall be d one as per GeM provisions only and IREL (India) Limited shall not be an yway held responsible.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
