1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

 If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are

validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 7. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

PRE QUALIFICATION CRITERIA

The bidder should submit the following towards Pre-qualification Criteria:

1. The bidder should be a OEM (OR) Authorised Dealer / Authorised agency of respective Medical Equipment for which the dealership certificate should be produced.

4.0 Earnest Money Deposit (EMD)

- 4.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.
- 4.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 4.6 The EMD is liable to be forfeited if:
 - i. The tenderer changes the terms and conditions or prices or withdraw his qu otation subsequent to the date of opening.
 - ii. The tenderer fails to accept the order when placed or fails to commence sup plies/works after accepting the order.
 - iii. In case bidder submits false/fabricated documents.
 - iv. In case bidder fails to submit SD within 30 days of receipt of work/supply ord er.
- 4.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to r equest and approval. MSME /SSI units are exempted from payment of EMD/ T DC provided they submit valid MSME/ NSIC certificate along with commercial bi d and to ensure that certificate pertains to the class of item/works for which floa ted.

5.0 Security Deposit (SD) (For supply orders above ₹ 5 Lakhs)

The successful tenderer has to submit Security Deposit **@5% of the contract value** in the form of RTGS/NEFT/ BG within 21 days of receipt of our PO as secu rity for satisfactory completion of the order. The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on abandonment of the supply order. The EMD can be adjusted towards Security Deposit. However, if EMD is submitted in the form of BG, fresh BG is to be submitted towards SD i n the prescribed format as per tender. If the Supplier fails to provide the securit y deposit within the period specified, such failure shall constitute a breach of th e Contract and IREL shall be entitled to make other arrangements for the repur chase of the stores contracted for at the risk and expense of the supplier and/or to recover from the supplier the damages arising from such cancellation.

6.0 Payment terms

Our standard payment term is 100% payment within 30 days from the date of r eceipt and acceptance of materials along with all relevant documents" **NO adv ance payment shall be made under any circumstances**. Interest @ 12% s hall be considered for evaluation of bids in case of supplier(s)/contractor(s) req uesting for payment earlier than our stipulated terms.

7.0 Liquidated Damages

Subject to Article -25, if the SELLER fails to deliver any or all of the GOODS or pe rformance the services within the time period (s) specified in the CONTRACT, the PURCHASER shall, without prejudice to his other remedies under the CONTRACT, deduct from the CONTRACT PRICE, a sum calculated on the basis of the CONTRA CT PRICE, including subsequent modifications.

Deductions shall apply as per following formula

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores deli vered late, for each week or part thereof of delay. The total damages shall not e xceed 10 (Ten) per cent of the value of delayed goods. The LD cannot exceed th e amount stipulated in the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value s hall be reduced proportionately for the delay and payment shall be released acc ordingly.

In the event the invoice value is not reduced proportionately for the delay, the P URCHASER may deduct the amount so payable by SELLER, from any amount fall ing due to the SELLER or by recovery against the Performance Guarantee. Both seller and PURCHASER agree that the above percentages of price reduction are genuine preestimates of the loss/damage which the PURCHASER would have suf fered on account of delay/breach on the part of the SELLER and the said amount will be payable on demand without there being any proof of the actual loss/or da mage caused by such breach/delay. A decision of the PURCHASER in the matter of applicability of price reduction shall be final and binding.

- **8.0** In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated i n Buyer ATC shall govern.
- **9.0** In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.
- 10.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be don e as per GeM provisions only and IREL (India) Limited shall not be anyw ay held responsible.

Disclaimer/अस्वीकरण
