NOTE: As per para 7.3.5 on (Clarification of Bids/Shortfall Documents) of the Manual for Procurement of Goods 20 17, issued by Ministry of Finance, Department of Expenditure, During evaluation and comparison of bids, the purcha ser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be given aski ng the tenderer to respond by a specified date. If the tenderer does not comply or respond by the date, his tender w ill be liable to be rejected. Depending on the outcome, such tenders are to be ignored or considered further. No cha nge in prices or substance of the bid shall be sought, offered or permitted. No post bid clarification at the initiative o f the bidder shall be entertained. The shortfall information / documents should be sought only in case of hi storical documents which pre-existed at the time of the tender opening and which have not undergone change since then. ii) The required EMD has not been provided or exemption from EMD is claimed without acceptable proof of exemption;

iii) The bidder is not eligible to participate in the bid as per laid down eligibility criteria(example: the tend er enquiry condition says that the bidder has to be a registered MSE unit but the tenderer is a, say, a large scale unit);

iv) The tenderer has quoted for goods manufactured by a different firm without the required authority let ter from the proposed manufacturer.

v) The bid departs from the essential requirements specified in the bidding document (for examp le, the tenderer has not agreed to give the required performance security); or

vi) Against a schedule in the list of requirements in the tender enquiry, the tenderer has not quot ed for the entire requirement as specified in that schedule (example: in a schedule, it has been sti pulated that the tenderer will supply the equipment, install and commission it and also train the p urchaser's operators for operating the equipment. - 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
