- 1. - 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

PRE-QUALIFICATION CRITERIA

The tenderer should submit the following towards Pre- Qualification Criteria:

- 1. Experience of having successfully completed similar works during last 7 years ending 31st January 2025 and the same should be either of the following. The tenderers should produce copy of work order in support of the same with satisfactory completion certificate from concerned authority/department/organization for similar works (documents to be submitted endorsing work experience).
- a. Three similar works, each costing not less than ₹7,79,400/-.

(OR)

b. Two similar works, each costing not less than ₹9,74,251/-.

(OR)

c. One similar work, costing not less than ₹15,58,801/-.

Definition of similar works: Similar works means works involving cleaning of building.

- 2. The bidder must have functional office established in districts of Kanyakumari / Tirunelveli / Thiruvanant hapuram /Thoothukudi as on 31st January, 2025. Bidder shall submit proof of registration of such office as per the Tamil Nadu Shops & Establishment Act 1947 with address proof or equivalent in Kerala State.
- 3. Financial:

Average annual financial turnover during the last 3 years, ending 31st March 2024, should be at least ₹5,8 4,550/-. (Copies of profit & loss account and balance sheets for the last 3 years are to be submitted) or IT r eturn duly filed duly audited by statutory auditor.

- 2. Relaxation in prior turnover and prior experience shall be given to MSEs / Start-ups (as defined by Depar tment of Industrial Policy and Promotion) as per Government Circular / Guidelines subject to meeting of quality and technical Specification.
- 3. The offers of the bidders who have defaulted in the past in execution of the contracts or in complying wi th the obligations as per the contract shall not be considered.

- 2.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the ten der. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-C ommercial Bid.
- 2.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 2.6 The EMD is liable to be forfeited if:
- i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the dat e of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting t he order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 2.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. M SME /SSI units are exempted from payment of EMD/ TDC provided they submit valid MSME/ NSIC certific ate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floated.
- 3.0 SECURITY DEPOSIT (SD),
- 3.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards sati sfactory completion of the order/works as under:
- a. For works contract valued more than Rs.2 lakhs.
- b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (D LP).

3.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guara ntee issued/ confirmed from any Scheduled Commercial Banks in India' or online payment to be confirmed sharing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender.

- 3.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalized Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.
- 3.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Guar antee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers cheque is to be submitted towards SD.
- 3.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on aban donment of the supply/ work order.

4.0 Penalty

Contractor should carry out the work as per the scope of works. If the contractor fails to carry out as per s cope of work, a fine will be imposed at the rate of Rs.1,000/- per day each area for the period of non execution of the work.

- 5.0 Working Hours: Work hours shall be between 7.00AM to 3.00 AM / 8.00 AM to 4.00 PM on all working d ays & Sunday (after allowing for formalities connected with documentation, site briefing etc). However bas ed on a written request from the contractor IREL (India) Limited may consider, in deserving conditions, ext ension of working hours beyond what is stipulated above and such extension shall be granted formally.
- 6.0 Period of Contract:
- a. The work shall be commenced within 15 (fifteen) days from the date of issue of work order.

Within this period (i.e. 15 days) contractor should complete all the statutory training i.e. Vocational Training (VT), etc. for their employees.

- b. The period of contract shall be 1 (one) year from the date of commencement of work.
- c. The company reserves the right to terminate the contract without assigning any reason by giving two w eek notice and no claim for any loss or damage or compensation for such termination of contract shall be payable by the company or maintainable against the company.
- 7.0 Payment terms
- a. Payment will be made based on mandays only. Payment for the mandays engaged shall be done on m onthly basis.
- b. The final bill, in all respect should be submitted by the contractor within 30 days from the date of completion of work.
- c. After completion of work all deposits will be released along with final bill.
- d. Payment will be made within 30 days of certification of contractor's bill by engineer-in charge/officer-incharge.
- e. All payments are subject to deduction of tax at source as applicable.
- f. GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the CGST/SGST Act 2017, Section 2 0 of the IGST Act, 2017and Section 21 of the UTGST Act, 2017.
- g. Our GSTIN33AAACI2799F1ZL and SAC code of service is to be mentioned in the bills.
- h. All payment will be done only through e-payment. Hence you have to provide your name, Account num ber, Name of the bank, nature of account (Savings/Current/CC/OD), IFSC, Branch code and cancelled cheq ue along with invoice.
- 8.0 Liquidated Damges for Delayed Execution of Contract:

If the Service Provider fails to perform the services within the time period(s) specified in the CONTRACT, the EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liquidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maximum of ten percent (10%) of contract value.

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling due to the Service Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agree that the above percentages of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be fin all and binding.

9.0 In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall gove rn

10.0 In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
