- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. PRE-QUALIFICATION CRITERIA

The tenderer should submit the following towards Pre- Qualification Criteria:

1. The tenderer shall submit copies of documentary proof towards execution of similar works during last 7

years from the date of tender as below.

Definition of Similar work:

"Similar work" means engagement of Forklift / Earth Moving Equipments (EME) on hired basis.

Tenderer should submit copies of the work orders executed along with work completion certificates from the client in support of compliance to the above criteria.

- 2. Average annual turnover of the tenderer during the last 3 years, ending 31.03.2022 should be ₹2,74,79 2/- (Documentary proof of the above should be enclosed). The tenderer shall submit copy of P & L account / IT return / turnover certificate for the last three years.
- 3. Tenderer has to submit documentary proof of owning / hiring / leasing of forklift or notarized undertaking to arrange & engage within 21 days of order.

Note:

- 1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be conside red under any circumstances.
- 2. Relaxation in prior turnover and prior experience shall be given to MSEs / Start-ups (as defined by Depar tment of Industrial Policy and Promotion) as per Government Circular / Guidelines subject to meeting of quality and technical Specification.
- 3. The offers of the bidders who have defaulted in the past in execution of the contracts or in complying wi th the obligations as per the contract shall not be considered.
- 4. Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the Procurement Policy for Micro and small Enterprises, 2012 (as amended time to time).

- 2.0 Earnest Money Deposit (EMD)
- 2.1 ₹20,000/- (Rupees Twenty thousand only)
- 2.2 Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limited, Manavalakurichi.
- 2.3 Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. The E-mail should conta in full postal address of the Tenderer, Tender No. for which EMD & TDC were paid, payment details includin g amount, and UTR No. and bank details from which payment was done. - 2.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.
- 2.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 2.6 The EMD is liable to be forfeited if:
- i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the dat e of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 2.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. M SME /SSI units—are exempted from payment of EMD/ TDC—provided they submit valid MSME/ NSIC certific ate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floated.
- 3.0 SECURITY DEPOSIT (SD).
- 3.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards sati sfactory completion of the order/works as under:
- a. For works contract valued more than Rs.2 lakhs.
- b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (D LP).

- 3.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guara ntee issued/ confirmed from any Scheduled Commercial Banks in India' or online payment to be confirmed sharing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender.
- 3.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalized Banks/ Schedule d Commercial Banks (other than Cooperative Banks) only acceptable.
- 3.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Guar antee, fresh Bank Guarantee in the prescribed format or demand draft / Bankers cheque is to be submitted towards SD.
- 3.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on aban donment of the supply/ work order.
- 3.0 Period of contract:

The successful contractor shall mobilize the work so as to commence the work within 21 days from the dat e of issue of Work order. The period of contract will be twelve months from the date of commencement. IR EL can utilize the balance hours if any, on the same terms and conditions of the contract based on satisfactory performance of the contractor on mutual agreement basis.

- 4.0 Penalty:
- a. In case the contractor fails to commence the work by mobilizing the equipment within 21 days of issue of work order, the contractor shall be liable to pay penalty @ Rs.3000/- (Rupees three thousand only) per day for each day's delay in commencing the work.
- b. During the contract period, in case the contractor fails to provide the forklift for work for more than two days in a months, he shall be liable to pay penalty @ Rs. 2500/- (Rupees two thousand five hundred only) per day for each day's non-engagement beyond two days. If the contractor fails to provide the forklift for a

consecutive period of 15 days, the work order shall be cancelled at the risk and cost of the contractor.

5.0 Payment Terms

Payment shall be done on monthly basis. 100% payment for the work executed shall be done within 30 da ys of submission of bill. Minimum payment shall be done for 3 (Three) hours a day on monthly average bas is. If total operating hour in a month exceeds the total operating days multiplied by 3, then additional pay ment for the hours exceeded shall be done based on hourly rate quoted by the contractor.

The contractor shall submit the bills on a monthly basis to the Engineer-In charge. All payments are subject to deduction of tax at source as applicable.

GST Law mandates Tax Deduction at Source (TDS) vide section 51 of the CGST/SGST act 2017, section 20 of the IGST act 2017 and section 21 of the UTGST act 2017.

All the payment will be done only through e-payment. Hence, you have to provide your name, account no. , name of the bank, and nature of account (savings/current/CC/OD), IFSC, branch code and cancelled check along with invoice.

6.0 LIQUIDATED DAMGES FOR DELAYED EXECUTION OF CONTRACT:

If the Service Provider fails to perform the services within the time period(s) specified in the CONTRACT, the EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liquidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maximum of ten percent (10%) of contract value.

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling due to the Ser vice Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agr ee that the above percentages of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be fin all and binding.

8.0 In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall gove rn.

9.0 In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IR EL shall govern.

10.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Limited shall not be anyway held responsible.

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
