- 2.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the ten der. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-C ommercial Bid.
- 2.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 2.6 The EMD is liable to be forfeited if:
- i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the dat e of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 2.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. M SME /SSI units—are exempted from payment of EMD/ TDC—provided they submit valid MSME/ NSIC certific ate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floated.
- 3.0 SECURITY DEPOSIT (SD)
- 3.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards sati sfactory completion of the order/works as under:
- a. For works contract valued more than Rs.2 lakhs.
- b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (D LP).

- 3.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guara ntee issued/ confirmed from any Scheduled Commercial Banks in India' or online payment to be confirmed sharing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender.
- 3.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalized Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.
- 3.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Guar antee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers cheque is to be submitted towards SD.
- 3.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on aban donment of the supply/ work order.
- 4.0 Completion Period: Within12 months from the date of the start of work order or transportation of 1800 MT of Monazite from IREL, Manavalakurichi to IREL OSCOM whichever is earlier. It is open to IREL to termin

ate the contract without assigning any reason or reasons by giving two weeks notice and no claim for any loss or damage or compensation for such terminations of contract shall be payable by IREL or maintainable against IREL. Firms, companies or other body corporate, submitting the tender should attach with the tender a duly certified copy of the authority of the person signing the tender to bind the firm, Company or body corporate as the case may be for fulfilling the contract.

If the performance of the contractor is found unsatisfactory, the contract is liable to be terminated on 15 d ays notice by us. If there is breach of all or any of the terms of the contract we may, at our sole discretion, revoke the contract and forfeit the security amount deposited by the contractor and also proceed against t he contractor for recovery of such loss or damage as we may sustain as a result of such breach on the con tractor's part. Company will not guarantee for any quantity within the period of contract. However contract or shall be bound to undertake lesser quantity or excess quantity during the above contract period on the same rate, terms and conditions.

5.0 Period of Contract: The period of contract is one year from the date of start of work or completion of tr ansportation of 1800 MT, whichever is earlier. If the entire quantity could not be transported within one ye ar from the date of start of work due to reasons attributed to IREL, the period of contact can be further ext ended for a maximum period of another three (3) months for the balance quantity on mutually agreeable b asis of IREL and the successful bidder. The work is to be started within 3 days from the date of intimation r eceived from IREL. It is open to IREL to terminate the contract without assigning any reason or reasons by giving two weeks notice and no claim for any loss or damage or compensation for such terminations of contract shall be payable by IREL or maintainable against IREL.

6.0 Payment Terms:

- a. The payment for the transportation work will be made within 30 days by IREL (India) Ltd., OSCOM after d elivery of Monazite cargo at destination against your bills for each load duly certified by our company offici als, subject to deduction of tax at source as applicable. Applicable G.S.T will be paid directly to the Govern ment by IREL (India)Ltd. Hence no G.S.T shall be paid by the contractor.
- b. GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the GST/SGST Act 2017, Section 2 0 of the IGST Act, 2017 and Section 21 of the UTGST Act, 2017.
- c. Please mention IREL (India) Limited GST number (33AAACI2799F1ZL) and HSN/SAC code of goods/servic es in your bills.
- d. All payments shall be done only through E-payment. Hence successful bidder has to provide Company n ame, Account number, Name of the bank.

7.0 LIQUIDATED DAMGES FOR DELAYED EXECUTION OF CONTRACT:

If the Service Provider fails to perform the services within the time period(s) specified in the CONTRACT, the EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liquidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maximum of ten percent (10%) of contract value

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling due to the Service Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agree that the above percentages of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be fin all and binding.
