- **NOTE: As per para 7.3.5** on (Clarification of Bids/Shortfall Documents) of the Manual for Procure 2. ment of Goods 2017, issued by Ministry of Finance, Department of Expenditure, During evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on th e bid. The request for clarification shall be given asking the tenderer to respond by a specified dat e. If the tenderer does not comply or respond by the date, his tender will be liable to be rejected. Depending on the outcome, such tenders are to be ignored or considered further. No change in pri ces or substance of the bid shall be sought, offered or permitted. No post bid clarification at the ini tiative of the bidder shall be entertained. The shortfall information / documents should be so ught only in case of historical documents which pre-existed at the time of the tender o pening and which have not undergone change since then. - iii) The bidder is not eligible to participate in the bid as per laid down eligibility criteria(example: the tender enquiry condition says that the bidder has to be a registered MSE unit but the tenderer is a, say, a large scale unit);
- iv) The tenderer has quoted for goods manufactured by a different firm without the required authority letter from the proposed manufacturer.
- v) The bid departs from the essential requirements specified in the bidding document (for example, th e tenderer has not agreed to give the required performance security); or
- vi) Against a schedule in the list of requirements in the tender enquiry, the tenderer has not quoted f or the entire requirement as specified in that schedule (example: in a schedule, it has been stipula ted that the tenderer will supply the equipment, install and commission it and also train the purch aser's operators for operating the equipment.
