1. 4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

SCOPE OF WORK:

Contractor shall carryout Mechanized loading & transportation of Tailings, SGM from Plant to differ ent Areas unloading, backfilling, leveling the backfilled areas and connected works. The contractor shall engage excavator and transporting equipments for carrying out loading & transportation of t ails, SGM and leveling the backfilled areas as directed by Engineer-In-Charge from the lease hold areas of IREL.

PRE-QUALIFICATION CRITERIA

The tenderer should submit the following towards Pre- Qualification Criteria:

1. Tenderer should have experience in successful completion of similar works during last 7 years e nding 31.03.2025 shall be either of the following:

a. Three similar completed works each costing not less than ₹12,40,000/-

(Or)

b. Two similar completed work each costing not less than ₹15,50,000/-

(Or)

c. One similar completed work each costing not less than ₹24,80,000/-

"Similar works" means

2. Average annual financial turnover during the last 3 years, ending 31st March 2024, should be at least ₹9,30,000/-. (Copies of profit & loss account and balance sheets for the last 3 years are to be submitted).

Note:

1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be considered under any circumstances.

2. Relaxation in prior turnover and prior experience shall be given to MSEs / Start-ups (as defined by Department of Industrial Policy and Promotion) as per Government Circular / Guidelines subject to meeting of quality and technical Specification.

3. The offers of the bidders who have defaulted in the past in execution of the contracts or in com plying with the obligations as per the contract shall not be considered.

4. Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the Procure ment Policy for Micro and small Enterprises, 2012 (as amended time to time).

OTHER TERMS & CONDITIONS

1.0 Bidders have to upload the following along with the Bid

2.0 The rate quoted shall be FOR IREL (India) Limited, Manavalakurichi. The items have to be supplied strictly as per the technical specification within the delivery period mentioned in the tend er.

3.0 EARNEST MONEY DEPOSIT (EMD)

3.1 ₹62,000/- (Rupees Sixty two thousand only)

3.2 Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limited, Manavalaku richi.

3.3 Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. The E-mail shou Id contain full postal address of the Tenderer, Tender No. for which EMD & TDC were paid, paymen t details including amount, and UTR No. and bank details from which payment was done. IREL's E mail id is purchase-mk@irel.co.in

3.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of open ing of Techno-Commercial Bid.

3.5 Offers without EMD or valid EMD exemption certificate shall not be considered.

3.6 The EMD is liable to be forfeited if:

i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent t o the date of opening.

ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after ac cepting the order.

iii. In case bidder submits false/fabricated documents.

iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.

3.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and ap proval. MSME /SSI units are exempted from payment of EMD/ TDC provided they submit valid MSME/ NSIC certificate along with commercial bid and to ensure that certificate pertains to the cla ss of item/works for which floated.

4.0 SECURITY DEPOSIT (SD)

4.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towar ds satisfactory completion of the order/works as under:

a. For works contract valued more than Rs.2 lakhs.

b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after noti fication of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of

completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (DLP).

4.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bo nds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guarantee issued/ confirmed from any Scheduled Commercial Banks in India' or online pa yment to be confirmed sharing Unique Transaction Reference (UTR) to the tender inviting authorit y as called for in tender.

4.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalized Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.

4.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of B ank Guarantee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers cheque is to be submitted towards SD.

4.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on abandonment of the supply/ work order.

5.0 PERIOD OF CONTRACT:

The period of contract shall be three months from the date of start of work or till completion of the entire quantity, whichever is earlier.

6.0 PAYMENT TERMS:

a. Payment to the contractor for the work done will be made fortnightly on submission of bills and after the verification of actual work done with weigh bridge statement generated by stores depart ment within 30 days from the submission of bills complete in all respect certified by Engineer-In-c harge subject to deduction of tax at source as applicable.

b. No mobilization advance shall be allowed as a general rule.

c. GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the GST/SGST Act 2017, S ection 20 of the IGST Act, 2017 and Section 21 of the UTGST Act, 2017.

d. Please mention IREL (India) Limited GST number (33AAACI2799F1ZL) and HSN/SAC code of goo ds/services in your bills.

e. All payments shall be done only through E-payment. Hence successful bidder has to provide Co mpany name, Account number, Name of the bank.

7.0 PENALTY:

For achieving the targeted quantity, the contractor shall deploy excavators and tippers continuous ly. However, if failure of any equipment occurs due to any emergency/breakdown, then it shall be the responsibility of the contractor to immediately make alternate arrangement to mobilize spare excavators, tippers in good working condition, either of his own or hired from outside agencies. Th e contractor shall ensure that checking of the spare equipment by company official is completed b efore inducting the same in the existing fleet. In case the contractor fails to mobilize spare equipments as mentioned above in good working condition within 3 days, he shall be liable to pay penalty @ Rs.5,000/- (Rupees Five Thousand only) plus applicable Goods & Service Tax per equipment for each day of shortfall of equipment from 4th day onwards till such time the equipment is mobilized.

The contractors should note that this tender is linked to mainly agreements made with various pri vate land owners after obtaining consent to temporary leasing for mining at inland deposits. There fore timely backfilling of tails is of paramount importance to ensure timely handing over of land to respective land owners.

8.0 LIQUIDATED DAMGES FOR DELAYED EXECUTION OF CONTRACT:

If the Service Provider fails to perform the services within the time period(s) specified in the CONT

RACT, the EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liq uidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRIC E, including subsequent modifications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maximum of ten percent (10%) of contract value

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling due t o the Service Provider or by recovery against the Performance Guarantee. Both Service Provider a nd EMPLOYER agree that the above percentages of price reduction are genuine pre-estimates of t he loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any pr oof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be final and binding.

9.0 In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC s hall govern.

10.0 In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipul ated by IREL shall govern.

11.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake don e by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Li mited shall not be anyway held responsible.

- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
